PRACTICE THRUST MESSAGE

In the coming months, Practice Thrust strives to implement a few new/on-going initiatives to SIA members for the betterment of architecture profession and to uphold professionalism of architectural fraternity.

First and foremost, Practice Thrust endeavours to launch the SIA Minor Works Sub-Contract For Use With Minor Works Contract 2012. The SIA Minor Works Sub-Contract For Use With Minor Works Contract 2012 is initiated by SMAP Committee after the launch of SIA Articles and Conditions of Contract for Minor Works 2012 (MWC 2012) in December 2012. The Conditions of Sub-Contract is intended to be used where an Employer under the Main Contract has chosen to exercise his rights to nominate sub-contractor and/ or supplier to be engaged by the Contractor under specific conditions as determined by the Employer. This standard form is suitable for use if Sub-Contract Sum is significant and it is reasonable for the Sub-Contract to take on the same or similar obligations as the Contractor in a corresponding arrangement with the Main Contract. This Sub-Contract contains contractual provisions which are in line with the SOP Act.

With this new Contract, there will be a series of seminar conducted to equip architects to gain better understanding of the Contract, understand their role, have the skill and knowledge to advise their Clients as well as administer the Contract in a professional manner.

Secondly, *Practice Management Framework (PMF)* is expected to be launched in Q4 2017/Q1 2018. PMF is a framework developed by architects for architects. This initiative was mooted with the intention to develop a systematic framework which would lay solid foundation for effective and consistent delivery of architectural services. With PMF in place, SIA members can look forward to a framework that addresses work practice, business and risk management relevant to architecture practice.

While it is important to develop a systematic framework, having SIA members to embrace and adopt it is equally critical. With this in mind, Practice Thrust will organise a *Practice Management Framework Course* to equip architects to develop their own management system that would suit their style of practice and lay solid foundation for effective and consistent delivery of architectural services.

Thirdly, the suite of SIA Building Contract 2016 – Without Quantities (Domestic & International), Design & Built (Domestic & International) and Sub-Contract (Domestic & International) was launched on 28 November 2016. Since their launch, Chairperson of Building Contract Committee and SIA Executive Director have been actively promoting the suite of new form of contracts to allied professionals. Besides promoting the new form of contracts, Building Contract Committee continues to review and address any shortcoming in these Contracts. Concurrently, the Committee is also actively working on Specimen Forms & Certificates, Guidance Notes and Building Contract With Quantities (Domestic & International). To equip SIA members with the knowledge, submission procedures, dos and don'ts in complying with authority requirements, the following seminars were/ are organised by Practice Thrust in 2nd quarter of 2017:

There were a few new requirements/legislations rolled out by the authorities. Salient changes were Amendments to Building Control (Buildability and Productivity) Regulations 2011, Revisions to Code of Practice on Buildability to raise productivity in the built environment sector and Amendments to Public Utilities (Water Supply) Regulations. Other new requirements were advisory notes from BCA on Good Practices for design, construction and maintenance of Infinity Edge Pools and Appointment Of Single Qualified Person For Landed Property Developments and Non-AC Projects.

PRACTICE THRUST REPORT : SIA Conditions of Sub-Contract for use in conjunction with the Minor Works Contract 2012

Together with the legal advisor, **Minor Works Contract Sub-Committee** is currently reviewing feedback from respective SIA Committees. Once the exercise is completed, the **Sub-Contract** will be launched to the industry. A series of seminar will be conducted to equip architects to gain better understanding of the **Sub-Contract** and master the skill to administer the **Sub-Contract**.

Practice Management Framework (PMF)

Practice Management Framework is a framework developed by architects for architects with the objective to lay solid foundation for effective and consistent delivery of architectural services. In the next 2 quarters, **SMAP Committee** will work with an appointed consultant to develop a programme and arrange meetings for the appointed consultant to visit participating firms to review and study their in-house management system.

SIA Building Contract 2016 - Without Quantities (Domestic & International), Design & Built (Domestic & International) and Sub-Contract (Domestic & International)

Since their launch on 28 November 2016, Chairperson of **Building Contract Committee** and SIA Executive Director have been actively promoting the **SIA Building Contracts 2016** to allied professionals. As of to-date, SIA had briefed SCAL, ACES, SPM, SIBL and SISV.

Apart from the briefing sessions, SIA had also invited allied professionals to provide feedback/comments on the suite of the new form of contracts. Currently, **Building Contract Committee** is reviewing the feedback received from quantity surveyors. Since their launch on 28 November 2016, the Committee has also been actively reviewing the Contracts to address any shortcoming.

Concurrently, the Committee is working on **Specimen Forms & Certificates, Guidance Notes and Building Contract With Quantities (Domestic & International)** and planning a series of seminar and workshop to equip architects and allied professionals with the knowledge and know-how on these new Contracts in 2017. Details on the seminars and workshops will be broadcast at a later date.

Review of SIA Conditions of Appointment and Architect's Services and Mode of Payment

The **SIA Conditions of Appointment** and **Architect's Services and Mode of Payment** was published in 2002. With drastic change to the practice landscape and legislations, **Architect's Appointment Committee** has been embarking on a review exercise with the objective to update the clauses therein to ensure comprehensiveness and to be in line with current legislations and practice.

The review exercise will also include working on description of *Basic Services* and *Additional Services* to be published on SIA website. **Architect's Appointment Committee** acknowledges that this review exercise is a challenging one and endeavours to complete it in next Council year.

Rene Tan RT+Q Architects Pte Ltd Project: House Off Cluny

Located close to UNESCO listed Botanical Gardens, the project is a 2 storey good class bungalow, built for typical family with children. The design is a partial courtyard scheme where the living quarters are centred around a large swimming pool which also serves as a water feature. The 3-sided courtyard opens out towards a large open garden.

The house has 3 wings, each a variation of the letter "C", forming a 3-sided courtyard. The living quarters are housed in two blocks - one 'C' rests on a long granite cladded wall which runs from the front of the house all the way to the rear of the site, the other seemingly floats above the swimming pool. The living room, meant for entertaining, is defined by a 'C' shaped shell, turned on its side, visually and spatially linked to the rest of the house at the 2nd storey level by a glass bridge.



Gwen Tan Formwerkz Architects LLP **Project: Open House**

Open House as an intermediate terrace typology serves to explore how multi-generation communal living can be celebrated vertically while the architecture responds appropriately to climatic and contextual elements.

The namesake of the project is inspired by the openness of its west fronting facade where the house is separated from the street via an open metal screen with solid ash wood infills above the ground floor. The porous facade created an opportunity for a heightened sense of connectivity to the surroundings while the internal skylit atriums provided a connective volume where activities across all levels can be seen or heard.

In a response to the site orientation, the bedrooms are stacked vertically at the rear where the morning sun is shielded by dense foliage while the west fronting facade is paired with a pool on the second level where afternoon sun is much loved. For a house that relies heavily on natural ventilation, several strategies for passive cooling are implemented across all levels.



In a usual circumstance, the front of the house is the most important - not in our case. House 24 is sited on a triangular plot, a constraint that we took on as an opportunity to really engage with the siting and planning of the house. The site adjoins a lushly landscaped state land that we endeavoured to take advantage of at every available opportunity and every habitable space.

As such, we turned the house away from the main road and neighbouring houses. and instead have the living spaces open out to the mature greenery beyond. The courtyard screen fronting the street is an exercise in rethinking the conventional entry sequence of residential dwellings, and an opportunity to explore what timber craftsmanship might mean in contemporary architecture.

There is a compression of space as one enters from the road and descends to the entrance foyer under the bridge. The space expands in the living room into a soaring double height space, further accentuated by the change in materials from grey stone and timber to a pure white space.

The house is also visually and programmatically defined by 2 long walls. The main one, described above, serves as a backdrop for the swimming pool as well as separates the semi-private zone from the private family room and bedrooms. The other wall intersects this perpendicularly and separates the bedrooms from the family room, expressed as a series of bookshelves that finally terminate as the pool shower room.

Project: Ramp House

A decision between building a small bungalow or a semi-detached typology had to be made. When the client shared his dream of extending his childhood memories of running about in his garden grounds to his two daughters, the answer became obvious- whichever scheme yields a maximum extent of gardens. We decided to ask "How can we have a longer stretch of external space to support two future marathon runners in the making?" An architectural element- the ramp became the driving force in the design. A ramp was designed to create an extension of running in the garden right up to the 20m pool at the roof top, where there is an abundance of sun in the day and star gazing opportunities at night. Linking the typically neglected rooftop pool to the garden makes it a destination or a transitional space when the girls play catching. The ramp is the speed trail for the girls or a slow stroll for the grandmother to the roof top.

- · Coordinate the flow of the construction project safety and health risks information among the stakeholders from the design stage, to construction stage until the handover to the Developer for occupation and maintenance.

Building science looks at a building as a system, to account for building objectives and to apply empirical techniques to effectively provide a solution to design problems. Understanding the physical behaviour of the building as a system and how this impacts energy efficiency, durability, comfort, productivity, health (mentally & physically) and indoor air quality is essential to innovating high-performance buildings. Often we look to lab documentation and high outcomes from test results as a benchmark to specify a product into a building, often overlooking the need to review the details behind the results, looking at product's aesthetics while compromising on functionality, maintenance and durability (and at times safety).

We talked about ceilings and go behind the often unmentioned empirical data behind lab tests and standards, its corresponding fundamental principles e.g. Acoustics .We relate it to "the list" of objectives which should be accounted for during the design stage, all of which will surely change how you view ceilings in your next project.

The site was previously fenced-in, inward-looking and did not contribute to the neighbourhood. A simple robust palette of finishes and motifs was adopted as a kit-of-parts system to stitch together surfaces and spaces of the new and existing.

The design scope includes architecture, interior design, signage, lighting, art and landscaping to deliver a holistically integrated environment. The porous and accessible nature of the Enabling Village creates an inclusive environment, integrating people with disabilities as equal in the community.

Project: GoodLife! Makan

Goodlife! Makan is an innovative social initiative created by Montfort Care, a voluntary welfare organisation, to support ageing-in-place, built around meaningful pastimes that address the physical and mental wellness of seniors. This cheerfully designed 360sqm recreational centre is situated at the void deck of a HDB block in Marine Parade, with a communal kitchen as its nucleus.

The place aims largely at reconnecting stay-alone elderly to the wider community to facilitate multi-generational exchanges. With cooking and dining together as the essence of the experience, this activity space provides opportunities for senior residents to interact and socialise through Singapore's rich and easily understood food culture, while developing roles and responsibilities from the rituals of food preparation and consumption. The facility reinterprets social settings for the elderly, as a pioneering and alternative model that is inclusive and cost-efficient to create and maintain across open neighbourhoods.

Why Albert Hong donated \$30m to SUTD

Architect's close brush with death has prompted him to do more for community

When Dr Albert Hong was hospitalised in 2013 for pneumonia, he was given a 20 per cent chance of survival - and he lived.

The pioneer architect's close encounter with death prompted him to do more for the community.

Soon after that, the philanthro-pist donated \$30 million to the Singapore University of Technology and Design (SUTD). Emeritus Senior Minister Goh

Chok Tong yesterday shared the story behind Dr Hong's donation to SUTD, which has named its largest lecture theatre after him.

In his speech at the dedication ceremony, Mr Goh called Dr Hong a good friend who had confided in him after recovering from pneumonia in 2013 that "there must have been a reason why God let him live". So he decided to give away most of his wealth.

New law to help architects work abroad

More than 1,500 architects registered here can soon practise in participating countries

It will soon be easier for architects here to internationalise their businesses and practise overseas, under changes to the law approved in Parliament yesterday.

The Architects (Amendment) Bill will enable any architect registered with the Board of Architects here to ply their trade in a "participating overseas jurisdiction", Minister for National Development Lawrence

Wong told the House. The new law will allow the Board of Architects to form arrangements. with its foreign counterparts.

These will recognise the more than 1,500 architects registered in

countries. These were signed by governments, but the changes will allow the Board of Architects to make these arrangements. They will also open up more op-

portunities for Singapore-registered architects to find work abroad, Mr Wong said

The two MPs who spoke on the Bill - Mr Louis Ng (Nee Soon GRC), and Nominated MP K. Thanaletchimi - asked how the Government would ensure that overseas architects meet local standards. Mr Ng said training and exposure

for architects from less developed countries may not be adequate to familiarise them with standards and codes here, pointing out that the standard of architectural practice could be affected. He asked how the profession here

imgapore and allow them to practise in those foreign countries.

Likewise, the board here would also have to recognise foreign architects registered in those jurisdicrions, which also makes it easier for them to work here.

Mr Wong told the House that with globalisation, it is more likely that architects here will practise in foreign countries.

"Many of our locally registered architects are well recognised for their skills and professionalism, and many of them are expanding their business overseas," he said, adding that the amendments to the Bill were timely, and would "enable our architects to operate more effectively in a globalised world".

At present, Singapore has mutual recognition arrangements with countries such as Australia and

could be protected.

In response, Mr Wong said foreign architects recognised in their countries would have to pass an examination set by the board here, to ensure they have knowledge of local practice laws, rules and regulations. Architects said the changes were timely. Ms Wo Mei Lan, director of Liu and Wo Architects, said: "This is

very useful for us. We are very developed and advanced in the region, and this opens up jobs abroad." Other notable changes in the law

included the raising of the maximum penalty for errant architects from \$10,000 to \$50,000.

More support, protection for designers

Local designers are set to receive better protection for the rights of their works and an easier time regis-tering new designs, under a series of proposed changes to the Registered Designs Act.

These were tabled by the Min-istry of Law (MinLaw) in Parliament yesterday, in a move to give stronger support to Singapore's design industry. The changes in-

clude broadening the scope of designs that can be registered, shifting ownership from commissioning party to designer, extending the scope and grace period provision, and streamlining the process for multiple applications. The Registered Designs (Amend-

ment) Bill is the first significant change to the Registered Designs Act since it was introduced in 2000. "The proposed legislative changes will update Singapore's design protection regime to take

into account latest trends in design and technology," MinLaw said in a statement. "It will support the growth of the design industry by making it easier for designers to protect their creative works." Designs that can be registered in-

clude virtual designs of non-physical products that can be projected onto a surface and have useful functions, such as a virtual keyboard. Designers will also he able to register colours, to protect them as a design feature in their products.

The designs of artisanal or handcrafted items, such as handmade jewellery, can be registered as well. Another key change is the shift of ownership from commissioning party to designer. Currently, design ownership goes to the party that commissioned the design. With the change, ownership goes to the cre-ator. This will minimise instances of designers inadvertently losing the rights of their designs. Designers will also have a longer grace period to apply for design protection.

Currently, a designer whose design is made public has six months to register it and can do so under limited circumstances. The change will extend the period to 12 months and cover any

Govt reviewing 4 areas for SkillsFuture Credit

its customers' pain points and alleviated their anxiety by anticipating their needs.

This shows the transformational potential of design. Traditional business strategy or policy starts from an objective, and then uses data to form tactics, with the customer receiving the experience at the end.

Design thinking has the opposite starting point – It starts by determining the experience that customers should receive and find

the best way to deliver. I experienced this first-hand when I was sent to San Francisco for a one-year attachment with

Last year, it acquired three creative services firms to expand its Interactive Experience division, IBM iX, and launched IBM Studios singapore.

It is a co-creation space where more than 100 designers, strategists and technologists collaborate to create experiences of the future. They apply the principles of design thinking to their product development

rncess. For example, the team worked with pilots from Singapore Airlines to understand their day-by-day flight planning activities, and then rapidly designed and built a suite of innovative iPad applications that helped them with their planning schedules. The pilots loved it because it was not technology designed to meet business objectives, but to solve human challenges. Productivity and business gains were a natural result.

While craft mastery continues to be a crucial skill of a designer, it is insufficient. The unfortunate stereotype of a designer today is that of a hipster sipping hand-brewed artisanal coffee,

WHY NON-DESIGNERS SHOULD CARE

Second, why should everyone else care about design? If designers cart solve complex problems, then the rest of us do not need to bother

with design, right? Wrong. If design is becoming of strategic importance to a whole range of businesses - from militinational corporations to small and medium-sized enterprises and government agencies – then everyone who leads these places should have a design mindset. In short, non-designers, too, need to be ambidextrous. Engineers, business strategists

and civil servants armed with a design mindset and skills are much quicker to identify customer value for their organisations. More critically, Fhave witnessed how engaging deeply with citizens has reinvigorated civil servants and given them a renewed sense of
