Yet another quarter packed with activities for the various Design Thrust Committees...

Archifest and Architours 2016

Archifest 2016 - our annual architecture festival - returns from 23 September to 9 October 2016 with a pavilion designed with 'Exhale' as its theme. Celebrating its 10th year in 2016, 'Exhale' challenges the rapidity and density of activities that define our pace of life, weigh in on the state of Singapore's built environment and breathe new life. From exhibitions, installations, conversations, workshops, markets to architecture tours, the Archifest Pavilion @ Raffles Place Park hosted an exciting programme of more than 50 activities that are diverse, informative, thought-provoking and fun. Our festival pavilion, designed by **DP Architects**, is arguably the largest art installation ever in Singapore!

ArchXpo and SIA Hospitality Lounge

Co-organised by SIA and CEMS, the 3rd edition of **ArchXpo 2016**, held from 28 September to 30 September, was the key showcase of relevant technologies, products and related services in the architecture and built environment industry.

The **ArchXpo 2016** was opened by the Guest-of-Honour, *Mr Desmond Lee*, Senior Minister of State for National Development and Home Affairs. SIA looks forward to further collaboration with CEMS on the next editions of **ArchXpo**.

16th SIA Architectural Design Awards 2016

A total of 13 Design Awards and 14 Honourable Mentions are awarded in six categories this year at the *Awards Presentation Dinner* held at the Conrad Centennial Singapore on 29 September. **DP Architects**' project, Goodlife! Makan won the "Best Project Constructed under \$2 Million" and the coveted "Building of the Year" was awarded to *Open House* by **Formwerks Architects.**

Congratulations to all the winning firms! Their winning entries were exhibited at the *Archifest Pavilion*.

2nd SIA-Uniseal G-Architect Award 2016

2016 marks the 2nd cycle for this Award. Submissions were received from Asian countries including Malaysia, India and Sri Lanka. The jury panel was impressed with *Dr Ken Yeang's* commitment to green architecture and has unanimously selected him as the 2016 laureate. *Dr Yeang's* works were showcased at the Archifest Pavilion.

Exhibition of St John's Home for Elderly Persons Finalists

This design competition was organised to generate new and fresh ideas and secure the best design for its *Future-Ready Home for the Aged*, providing facilities and services not only to its present residents but also to the elderly living in the surrounding precincts. The winning and six shortlisted submissions were exhibited on two occasions; first at National Design Centre in August and then at the Archifest Pavilion.

The Singapore Architect, Issues No. 04 and 05

The physical pages and the covers of 4th issue, theme 'Eco', are themselves motifs central to the theme of this issue. The editors hoped that, with recycled craft paper and recycled corrugated cardboard as the medium of the issue, the message is clear—we should aim to return to the Earth what we consume.

Architecturally, a skin is the external most layer of a building. The skin wraps around and protects the interior of the building from the external environment. The 5th issue explores these various aspects of architectural skin with the hope of shedding new insights on this obvious but much neglected architectural element.

SIA-Getz Architecture Prize 2016

The biennial SIA-Getz Architecture Prize honours architects who have contributed significantly to the progress of architecture in Asia. It accords recognition and promote emergent architects in the region. The 6th cycle of the Architecture Prize attracted 17 entries from the region. The 2016 Laureate will be awarded at a special presentation ceremony in November.

PRACTICE THRUST MESSAGE

In Council Year 2016/2017, Practice Thrust is not only actively engage with respective authorities to review and participate in regulations/policy formulation, but endeavour to organise as many and relevant seminars to equip the practitioners with important practice knowledge affecting architectural profession.

With the new legislation from SCDF on the Performance-Based Design Approach to Fire Safety Waiver Application, a seminar to equip the practitioners with knowledge on this new legislation was organized on 19 August 2016. The above was one of the seminars organized by Practice Thrust in last quarter. The other seminar organized was 'The New Norms in Façade Lighting! - From Design to Maintenance'.

Practice Thrust continues to pursue in reaching out and educate the general public on the scope of works, roles and responsibilities of an Architect through 'Why Architect? Forum'. The recent Why Architect? Forum was organized on 2 October 2016, in conjunction with the Archifest 2016. The forum was held at **Library@Orchard** and was attended by around 60 people from house owners, professionals to students. The forum also shared who is an Architect, common misconceptions of an Architect, difference between traditional building contract and Design and Build. The other major achievement in last quarter was completion of review exercise of the SIA Arbitration Rules. The SIA Arbitration Rules Edition 3 is scheduled to launch in the 4th quarter of 2016.

In the next few years, Practice Thrust endeavours to develop the Practice Management Framework (PMF) to address work practice, business and risk management relevant to the practice of architecture, review SIA Conditions of Appointment and Architect's Services and Mode of Payment, SIA Conditions of Sub-Contract for use in conjunction with the Minor Works Contract 2012 and Partnership Agreement Checklist.

EDUCATION THRUST MESSAGE

It has been a highly enriching quarter of learning, knowledge sharing and exchange for the Education Thrust. Besides the wide array of seminars and courses organised by the Thrust, there were two key note events that received particularly good responses and participation.

First, as part of our SIA Inspirational Talk Series by today's movers and shakers, the Thrust had conducted another successful talk on 9 September 2016, with our Deputy Prime Minister *Tharman Shanmugaratham* on "Our City and People: A Future in our own Image". The turn-out of the event was very positive, with a theatrette full of 150 architects who are SIA Members attending the talk.

Issues raised during the talk with DPM revolves around our country's and our profession's future, focusing on subjects such as architect's statutory duties and fees, future of our profession, retaining talent and building our intellectual capital in promoting more research and development, etc.

Another key event that Education Thrust had successfully organised was this year's SIA Conference (formerly known as Archifest Conference) on 28 September 2016, in conjunction with the **ArchiFest** and **ArchXpo 2016**. It is an annual key note event, highly anticipated by our fraternity where subject experts and thought leaders local and worldwide get together, to share and exchange latest ideas and ideologies, about various challenges as well as innovative solutions for our evolving global urban landscape.

Seven speakers of diverse cultural and professional backgrounds, from five countries, in three continents, were invited to discuss on the conference theme "SlowCity". They were Mr Martin Duplantier from Martin Duplantier Architectes, Mr Stanley Lung from Turenscape, Mr Michael Koh from Centre for Liveable Cities, Mr Bjorn Low from Edible Garden City, Mr Ling Hao from

Linghao Architects, Prof Giuseppe Roma from Cittaslow International, and Mr Felipe Correa from Somatic Collaborative LLC.

The conference subject "SlowCity" provoked thoughts in our context of Asia, a region facing unprecedented urbanisation and growth. The phenomenal rate of transformation of our physical and psychological space, brought into questions, strains to the environment as well as psyche of our society. It questioned the way architects design and practice, as well as long term sustenance and sustainability. The conference served as a strategic platform to explore alternative movements that can be transformative to our current way of life, with our distinguished speakers offering deeper insights for this

As a bid to promote architectural excellence and an initiative to bring young architects, building professionals, designers and students together, YAL is also spearheading a brand new event, known as **OPEN STUDIO.** To be held similar to a "Pecha Kucha" format, the event will allow these young individuals to showcase their works and share their ideas, at the same, providing a platform for open discussions between different groups of design professionals.

The theme of this inaugural event is "Unbuilt Dreams", and will be held on 2nd December 2016 at SIA premises on Neil Road. SIA hopes that, with the introduction of this event, it will enable a wider awareness about the various parts of the architecture fraternity and in the process, foster a closer design community, where dialogues and exchanges in architecture design can happen.

The Membership Committee has been completed background work on the online installment payment platform for new membership applicants, and this will be launched by end-2016. The platform serves as an incentive to the applicants for the payment of membership subscription fees.

To recognise the hard work and contribution given by the committees, SIA is pleased to announce that there will be an implementation for the waiver of membership fees for nominated and recommended committee members. The waiver of membership fees is based on sufficient attendance, and nomination by respective Committee Chair to nominate deserving members, based on the value the members bring to the meetings and the Committee, in general. More details will be announced by the end of October 2016.

The Membership Committee has also begun road shows in the Universities, promoting our Student Membership scheme to these Institutes of Higher Learning. This is part of our effort to foster a greater connection between students of architecture and professionals, thus giving them a platform for engagement when they are in school, and when they graduate.

For the first time in several years, SIA has also sent a badminton team for the Inter-Professional Games, captained by *Prof Richard Ho*. The team comprises three Men's Doubles teams, one Women's Doubles team and one Mixed Doubles team. BOOK REVIEW:

Dare to be different - The Albert Hong Story

Published by World Scientific Publishing

The 156-page book is now available in bookstores at \$74.50 (before GST).

In this autobiography, Dr Albert Hong shares his life journey, from humble beginnings to an illustrious career and distinction in society. It is also a success story – of how, guided by Dr Hong, a small architectural practice has grown to be one of the biggest practices in Southeast Asia.


As elucidated in the book, Dr Hong joined **RSP Architects Planners & Engineers** in 1964. Then known as **Raglan Squire & Partners**, the firm was renamed to its current name in 1980. From just a small firm then, Dr Hong has transformed it to become one of Asia's leading architectural firms. He had the vision to enter the Indian market 18 years ago, making it the largest architectural practice in India then.

Under the leadership of Dr Hong, **RSP** has been at the forefront of shaping Singapore's built environment, creating many of our iconic buildings and landmarks. His bold vision, passion and perseverance has brought Singapore's brand of architecture abroad and left many imprints around the world.

Dr Hong has also been working behind the scenes in shaping architectural education through serving in several schools' advisory committees. He had pushed hard for a second school for design and architecture some 40 years ago, and this has come to fruition with the opening of the second architecture school in the **Singapore University of Technology and Design (SUTD)**, to which Dr Hong has also donated a substantial sum.

Dr Hong, in recognition of the knowledge he acquired at Birmingham and from *Professor Oscar Naddermier* in particular, donated a large sum of money to fund a professorship in the name of *Oscar Naddermier Professor of Architecture in History, Theory and Cultural Context.*

The autobiography also documents how Dr Hong championed SIA and architecture, when he served as SIA's Board of Trustees since 1975 and as its President for three terms (1973 - 1976). He believed in the value of promoting architectural excellence, and saw the potential in the important role that SIA could play in enhancing the architectural profession and promoting good design. Dr Hong's belief in SIA was so strong that he personally contributed to the development of the SIA Building Centre and was responsible for securing a Ioan to purchase SIA's premises at Neil Road. He even paid for the salaries of SIA's staff on many occasions during its earlier days. More recently, he demonstrated his strong support of SIA by donating \$1 million to help in the renovation of the SIA premises. These efforts laid the foundation for SIA to grow to what it is today.



As described in the book, one of the key values close to Dr Hong's heart is his passion for education, to which he had contributed extensively

Drawing from his own personal experience as a student, Dr Hong has an immense personal passion in helping needy students pursue their education – he only had a one way ticket to London, and supported his education by working at ice cream and chocolate factories and the post office throughout his university days. Over the years, he has given out many scholarships to students and donations to schools without any strings attached. One of his major donations was \$\$2 million made some 25 years ago to the Raffles Institution (RI), his alma mater, where distinguished leaders have been educated, including Singapore's first Prime Minister Lee Kuan Yew and Emeritus Senior Minister Goh Chok Tong.

At the heart of all his efforts and contributions, Dr Hong is an outstanding entrepreneur and businessman. He learned early in his working life that being a good architect doesn't automatically mean you're a successful architect, believing that, without projects, there is little point in being a great architect. Thus, he had built many business connections that contributed to the success of his firm. As co-chair of the **Singapore-British Business Council** he established many strong business links between Singapore and other countries. In recognition of his significant efforts, Dr Hong was given the award of the *Officer of the Most Excellent Order of the British Empire* by *Queen Elizabeth II* in 2009. The award was presented to him in person by *His Royal Highness, the Duke of York, Prince Andrew.*

For his long and dedicated service to the development of Sarawak and Malaysia, he received the distinguished award of "Panglima Negara Bintang Sarawak" by Tuan Yang Terutama Yang di-Pertua Negeri Sarawak in 2008, giving him the title of "Dato Sri". For his entrepreneurial abilities and achievements, Dr Hong received the prestigious Businessman of the Year award for 1994, which was presented to him by the then Prime Minister, Mr Goh Chok Tong.

Giving back to society is a hallmark of Dr Hong, who strongly believes that success brings obligation. In giving back to the community, he served on many boards of public bodies over the years, and had made many donations to institutions and individuals. Among the board he served included the **Construction Industry**Development Board (CIDB), the Singapore Broadcasting Corporation (SBC), Board of Trustees of the Chinese Development Assistance Council (CDAC), the Housing and Development Board (HDB), and the Singapore British Business Council (SBBC). He has donated to many institutions, including the Raffles Institution (RI), the Singapore University of Technology and Design (SUTD), the University of Central England in Birmingham

and **Singapore Institute of Architects (SIA)**. He has also supported scholarships for needy students and donated to individual students, with no strings attached. In spite of the challenges of changing times, Dr Hong's unwavering determination and entrepreneurial spirit in pushing boundaries and transforming Singapore's urban landscape here and abroad is truly inspiring. His continuous dedication in contributing back to society makes him an exemplary role model for the younger generations.

The autobiography succinctly explains the qualities of a man who has had a successful career, contributed to a successful architectural firm, and has led a fulfilling life. Some of the salient points beneficial for the reader include the need to maintain integrity, honesty, uprightness and fairness, hard work, appreciation for others, compassion, treasuring talent, friendship, fostering connections and giving back to society.

This is a book for anyone aspiring to make a difference in one's life and career.

Design Competition Winner - RGB Pavilion by DP Architects



Singapore Institute of Architects (SIA) is pleased to announce the winning design for Archifest 2016 Pavilion Design Competition: RGB Pavilion by DP Architects.

This temporary structure and 'pop-up' event space, designed to inspire visitors to rethink architecture and engage in conversations about our urban environment, was built on the grounds of Raffles Place Park and opened to the public from 23 September to 9 October 2016.

Responding to the Archifest 2016's theme 'Exhale', the design team DP Architects seeks to challenge the rapidity and density of activities that define our pace of life, weigh in on the state of Singapore's built environment and breathe new life into it, by their winning entry.

The theme 'Exhale' examines the rapid pace of life that is often associated with a dense city. 'Exhale' questions the city's ability to accommodate people who are searching for a different tempo. 'Exhale' challenges the inhabitants of the city to dictate their own rhythm of life.

RGB Pavilion: A zero waste pavilion made of construction netting and scaffolding pipes, multiple layers of colour overlap and interact to form secondary, tertiary hues – this creates a nuanced and playful urban experience.





Design Concept.

The RGB Pavilion is composed entirely of construction site materials: namely safety netting suspended on a frame of steel scaffolding. The deliberate use of only construction materials is a bold celebration of Singapore's fast-paced city life through continual urban intensification and gentrification. In the heart of the CBD, Archifest 2016 pavilion is a gigantic, technicolor habitable urban art sculpture that plays on the interaction of multiple primary color layers that overlap to produce a vibrant spectrum of secondary and tertiary colors. Once inside the pavilion, the surrounding CBD fades away and is replaced instead by a psychedelic selfie tunnel.

The pavilion's layered design encourages visitors to not only revel in the spectacle of color, but also to explore the transformation of colors arising from the changing combination of netting layers that fall within their effective field of view. Overall, the RGB Pavilion is a playful fusion of color which instantly perks up the entire plaza catching the eye and drawing people toward this photogenic artefact.

Singapore Red Cross(SRC) is a homegrown humanitarian organisation, dedicated to relieving human suffering, protecting lives and dignity and responding to emergencies since 1949. SRC serve the vulnerable through the blood donor recruitment programme, home and day activity centre for the disabled, transport aid, food aid, and community first aid. Beyond Singapore shores, SRC mobilise and translate contributions from the donor community to relief and recovery, rehabilitation and reconstruction efforts, with the aim of helping communities affected by disasters.

In partnership with the Singapore Institute of Architects(SIA) Corporate Social Responsibility(CSR)initiative, a design competition was held for the redevelopment of **Red Cross House** to generate new, fresh ideas for a new office block and redevelopment of **Red Cross House** entailed the following:

The Red Cross House Redevelopment Project attracted **49 entries.** The selection of the winning scheme was done through rigorous evaluation and Judging Panel assessment sessions. **ONG&ONG Pte Ltd was selected as the winning scheme for this design competition.**

When completed, this new 8-storey office tower will connect Red Cross House with an elevated event plaza, creating a physical transition via a detached office lift core that connects with the event space.









ST JOHN'S HOME FOR ELDERLY PERSONS DESIGN COMPETITION:

Aamer Architects Pte Ltd

St John's Home for Elderly Persons provides shelter and care for the physical and spiritual needs of such elderly persons who have no home or suitable accommodation and no children or close relatives who have adequate facilities resources to look after them. The Home is open to all regardless of race and creed.

As part of Singapore Institute of Architects(SIA) Corporate Social Responsibility(CSR) initiative, together with **St John's Home for Elderly Persons**, a two-stage Design Competition was organised to generate new and fresh ideas and secure the best design for its *Future-Ready Home for the Aged*, providing facilities and services not only to its present residents but to the elderly living in the surrounding precincts i.e. Sennett Estate, Potong Pasir, Joo Seng and Bidadari Town and the wider community. The St John's Home for Elderly Persons design competition attracted **52 entries** from which 7 schemes were shortlisted to proceed to Stage 2. The selection of the winning scheme was done through rigorous evaluation and Judging Panel assessment sessions. **Aamer Architects was selected as the winning scheme for this design competition**.

Juries' Citation

This winning scheme is set apart from the rest by its compact building mass and distinctive facade character. Its relatively small building footprint allows for greater use of the ground floor area for open programs and flexibility, as well as efficient core placement. With the ground space freed up, the chapel at the ground floor is designed to enhance the sense of entry and identity of place with its bold roof projection, while acting as a green roof deck for the spaces above.

Deeper review of the spatial organisation of the typical floor plan shows the residential units angled, offset and carefully juxtaposed to produce a serrated plan profile, which helps to address privacy, planting, views and climate. Interior spaces of the bedroom units are well resolved, with thoughtful consideration for the lifestyle of the residents.

Overall, the scheme manages a fine balance of realistic constructability, with a well crafted vision of a place which is definitive of the future St John's Home.







PRACTICE THRUST REPORT:

Practice Management Framework (PMF)

The Practice Management Framework is a framework developed by architects for architects with the objective to lay the foundation for good and consistent delivery of architectural service, to lift the standard of professionalism and status of the profession. Moving forward, the SMAP committee will arrange a meeting with the participating firms to:

- 1. Go through the brief scope of work for the consultant
- 2. Discuss proposed consultants and arrange to brief them so that they can quote their fees.
- 3. Interview consultants and make a recommendation to SIA Council on which one to appoint.
- 4. Work with the appointed consultant on the programme.



Review of SIA Arbitration Rules

The revised rules will address the arbitration clauses in our current forms of building contracts, but which may be lacking in sophistication under today's arbitration context and needs. The Alternative Dispute Resolutions Committee has completed the review exercise and plans to launch the revised rules in Q4 2016.

Review SIA Conditions of Appointment and Architect's Services and Mode of Payment

SIA is reviewing and updating the clauses for Conditions of Appointment and Architect's Services and Mode of Payment to ensure it's comprehensiveness and that it is in line with current legislation and practice. The review exercise will also include working on description of Basic Services and Additional Services to publish on the SIA website. The objectives are to provide reference for members and the public so that members are not compelled to provide free services for scope which is beyond basic service and also to educate the client that design needs to be protected, respected and duly compensated.

SIA Conditions of Sub-Contract for use in conjunction with the Minor Works Contract 2012

V

After the launched of SIA Articles and Conditions of Contract for Minor Works 2012 (MWC 2012) in December 2012, together with the legal advisor, SIA embarked the review exercise of SIA Conditions of Sub-Contract for use in conjunction with the Minor Works Contract 2012. The Conditions of Sub-Contract is intended to be used where an Employer under the Main Contract has chosen to exercise his right to nominate a sub-contractor or supplier to be engaged by the Contractor under specific conditions as determined by the Employer. This standard form is suitable for use if the Sub-Contract Sum is significant and it is reasonable for the Sub-Contract to take on the same or similar obligations as the Contractor in a corresponding arrangement with the Main Contract. This Sub-Contract contains provisions in line with the SOP Act.

The drafting exercise was completed and is now gathering feedback from respective SIA Committees.

Partnership Agreement Checklist

Given the evolution of the profession towards specialization to address the complexities of a project, the Architect's Appointment Committee is working on guidance notes/checklist to encourage more collaboration among Architects.

This is also to make clear to the industry that specialized fields do not form part of basic service, and one firm alone should not be expected to be able to offer services beyond what constitutes basic service. This checklist is intended to serve as a template to facilitate partnership/collaboration among members, as well as with other consultants, local and foreign.

In the event of any deviation from the Fire Codes, QP's have to apply for a waiver to SCDF for approval. SCDF would assess the reasons for the waiver issue and decides whether the waiver issue can be supported.

From 1 July 2016, QP's were required to provide objective assessment based on fire engineering study to substantiate the waiver application to some of clauses/conditions in the Fire Codes. What are they and how to establish the fire and life safety can be ensured in the waiver application?

The speakers, as Fire Safety Engineers, provided the understanding of what a performance-based design approach is to fire safety waiver and recommended solutions to achieve a positive outcome of fire safety waiver application together with case studies.

The role and operative model of the Architecture Practice has been a neglected topic. The exceptionally successful firms are either small boutique studios or mega corporation-like establishments. While the education of an Architect offers training in creative design and analytical skillsets, it tends not to address the reality of running a business. This is not to say that commercial concerns outweigh creative priorities – but rather suggests that financial rigour and design quality are in fact mutually beneficial.

The talk covered *Frven Lim's* concept of the **Design Enterprise** which he has developed over the past 6 years through personal research. Presented using diagrammatic models to suggest the operative modes of sustainable design-office typologies, the content questioned whether business and architecture can be the same thing.

The contents were also illustrated via a juxtaposition and comparison of projects that *Frven Lim* has been involved in both in Singapore (at **Surbana**) and in London (at **Adjaye Associates**). The talk was immensely beneficial for practitioners who are interested in the discourse between design-focused and financial-focused modes of operating.

New CBD in Jurong to offer flexible spaces for future economy

URA unveils third precinct, which will be home to the KL-Singapore High Speed Rail terminus

SINGAPORE'S second central business (CBD) district, the **Jurong Lake District (JLD)**, will feature adaptable spaces for the future economy, given that business cycles will be shorter, and that businesses will have to adopt rapidly emerging technologies and more flexible business models.

CBRE's managing director of industrial and logistics for Asia, *Dennis Yeo*, welcomed the announcement by the **Urban Redevelopment Authority (URA)** on Monday about the approach taken in the master planning of the JLD. He said: "Flexibility in real estate solutions will be vital in the new economy and help fill the gap for companies that do not qualify to use Business 1 (light industrial) space currently because they do not have manufacturing activities for instance; at the same time, they don't need to be in an offce building either."

Such occupiers may find rentals of office space too high and the set-up too restrictive for creative juices to flow. "The Internet of Things will spawn a lot of new businesses. One way for Singapore to stay ahead in the game and attract demand is by creating suitable spaces for them. The authorities may come up with a new zone or subzone," he suggested.

The URA and the Jurong Lake District Steering Committee chaired by National Development Minister Lawrence Wong have identified adaptable spaces for the future economy as a goal to guide the district's master planning.





As Singapore's second central business district, the JLD will consist of a core area around the **Kuala Lumpur-Singapore High-Speed Rail (HSR)** terminus. The area will comprise high-quality office spaces with mixed uses and be surrounded by clusters of business parks that provide flexible and adaptable work spaces for a good mix of complementary businesses and services of varying sizes.

Examples include research and development facilities, educational and training institutes, small and mid-sized firms, business incubators and investment terms.

The URA said: "This will create a diverse and highly connected ecosystem that promotes knowledge-sharing, innovation and collaborations between businesses within the district and beyond, and facilitate the meeting of their evolving needs in the future economy."

Cushman & Wakefield research director *Christine Li* said: "We could see things like an **Airbnb** campus, or a **Facebook** institution spring up in the vicinity, given the close proximity to tertiary institutions."

In launching its request for proposal (RFP) and inviting multidisciplinary teams to develop master plan proposals for the JLD, the URA also unveiled a third new precinct in the district. Called **Lakeside Gateway**, this precinct has been envisioned as a mixed-use business precinct and home to the HSR terminus, which will anchor the JLD as "a district of the future" and Singapore's second CBD.

A large part of the 112-hectare precinct is occupied by the **Jurong Country Club**, which has been acquired by the government. The JLD's two other precincts unveiled earlier are the commercial hub of **Jurong Gateway** and the leisure precinct of Lakeside.

The URA said **Lakeside Gateway** has potential for 4 to 5 million sq m of total gross floor area. Possible developments here include offces, business facilities, retail, entertainment, food and beverage, quality waterfront homes, hotels, recreational facilities and inclusive public spaces.

 $\it Ms\ Li$ suggested incorporating landed homes and low-rise condos equipped with smart features and boasting waterfront views, which could give rise to a more affordable "**Sentosa Cove** in the suburbs" .

The URA said that in the longer term, **Lakeside Gateway** could be integrated with the surrounding areas such as the **International Business Park, Teban Gardens** and **Pandan Gardens**.

A key guiding goal in the master planning of the JLD is to achieve a more aggressive public transport mode share - one that is higher than the national target, which is 75 per cent by 2030. *Minister Wong* said that as a CBD in the heartlands, the JLD will drive Singapore's growth in the future economy and cater to the needs of businesses, residents, visitors and Singaporeans from all walks of life.

It will be distinguished by its high connectivity, accessibility and environmentally-friendly features, where smart and green mobility options are the choice modes of commute.

The district will be a hub for smart innovations, and be the home of sustainable urban infrastructure that will boost productivity and manpower efficiency, as well as stand out as a "delightful and inclusive destination" for the community, defined by its greenery, extensive water bodies, built heritage and vibrant public spaces, he added.

JLL's head of South-East Asia research *Chua Yang Liang* described the plans for a socially inclusive district "rather intriguing".

"This will be the first time in Singapore's development history that we could be integrating a CBD within a largely residential and industrial area. Back during the nation-building days, the CBD was largely cleared of population."

Savills Singapore research head Alan Cheong suggested that the Master Plan be loosely interpreted as a Concept Plan to allow for flexibility, given that any physical architecture for the JLD could be rendered obsolete by quantum leaps in technology.

CBRE Research's head of Singapore and South-East Asia Desmond Sim suggested that to be future proof, the JLD Master Plan should provide for an infrastructure and land-use mix that is flexible in space usage within proposed developments as a key feature; this way, businesses can be nimble amid shorter business cycles.

"One possibility is the promotion of mixed-use developments with office, industrial/business parks and retail components. This could translate to more white sites being included in the Master Plan."

From among the multi-disciplinary teams participating in the RFP, the URA will shortlist up to five teams, which will develop their *Concept Master Plans* for JLD. When this is done, they will each receive an honorarium of \$\$200,000.

The team with the best *Concept Master Plan* will be appointed in February 2017, and work with the URA and partner agencies to draw up the *Draft Master Plan* for the JLD.

There will be an exhibition of the *Draft Master Plan* around the third quarter of next year, during which the public will be invited to give feedback. After that, the appointed team will work with the URA to refine the plans. When this has been done, the team will be awarded S\$2 million.


Wong Heang Fine, group CEO of **Surbana Jurong**, which has said it will take part in the RFP, commented: "The amalgamation of transportation, technology and sustainable design principles will set new benchmarks for future townships and cater to new industries in Singapore."

Also looking to participate in the RFP is **DP Architects**. Its director Seah Chee Huang noted that the proposal also calls for "inclusivity of the community that celebrates our social values, memories as well as preservation of built heritage such as the (current) **Science Centre** and the (former) **Jurong Town Hall**".

SINGAPORE WINNERS AT ARCHITECTURE AWARDS

Eight Singapore projects took home awards at the prestigious International Architecture Awards 2016. These winners spanned a wide range of typologies.

Residential project winners are Paterson 3, two corner terrace units off Orchard Road by AR43 Architects; and a bungalow in Cornwall Gardens by Chang Architects.

Condominiums Bliss@Kovan by Look Architects and d'Leedon, off Farrer Road and designed by the firm of late architecture doyenne Zaha Hadid, also won.

Three mammoth projects also caught the jury's eye. They are the 667,362 sq ft Yale-National University of Singapore College campus by Forum Architects; the ArtScience Museum at Marina Bay Sands and the upcoming Jewel Changi Airport (above). Both are by Safdie Architects.

An interesting project that won was conceptual design Bamboo Skyscraper by CRG Architects.

The architects envisioned tall buildings that made use of the hardy natural material.

The International Architecture Awards is organised by the Chicago Athenaeum: Museum of Architecture and Design, and The European Centre for Architecture Art Design and Urban Studies. It is the largest and most extensive global architecture awards programme in the world.

Projects that were judged included new skyscrapers, commercial buildings, urban plans, private residences and real estate properties that have good design, construction, planning and sustainability.

There were 132 winners this year from 43 countries, including Japan, Saudi Arabia, South Korea and the United States.





Twelve HDB Construction Awards for quality building were also given to construction firms.

Community-centric and environmentally sustainable features are part of HDB's vision for public housing, said Mr Jeremiah Lim, HDB's deputy director of design policy. "We hope to do these in more projects all over the country."

One of the winning projects for design was SkyVille@ Dawson by WOHA Architects. The communi-ty-centric design includes the con-cept of "sky villages", with each clus-ter of 80 homes sharing one sky gar-docardose positions.



New green standard in store for residential buildings

In the future, smart technologies will be among the criteria needed for developers of residential build-ings here to get their buildings

Green Mark-certified, Announcing this at the opening of the Singapore Green Building Week yesterday, Minister for National Development and Second Minister for Finance Lawrence Wong said that the updated Green Mark Scheme will take into account the use of technologies, such as sensors, to track real-time energy usage.

The scheme will also look at other features such as responsive wall facades that reduce heat gain in a building. The scheme's current criteria do not require the use of such technologies.

Launched by the Building and Construction Authority (BCA) in 2005, more than 2,800 buildings have been certified under the Green Mark Scheme in Singapore. Under the scheme, a building's

environmental impact is evaluated in areas including energy and wa-ter efficiency, and indoor environmental quality.

More than 31 per cent of Singapore's built area is now Green Mark-certified, and the aim is to increase this to 80 per cent by 2030.

The new set of criteria will be tested for a year before being fully implemented after consultation

with the industry, according to BCA chief executive John Keung.
To encourage buildings to

improve their energy efficiency, the BCA will also publicly put out building energy consumption data, but without revealing the names of the buildings.

Major cities such as Boston and New York already have mandatory disclosure of building energy per-

formance and the BCA is working towards implementing this in Sin-gapore in the next few years.

We hope building owners, and even occupants, can make use of this data to assess where their building performance stands and develop cost-effective solutions to reduce energy consumption and car-bon footprint if they find that their building is less energy efficient than similar building types," said

Dr Keung. In his speech yesterday, Mr Wong said buildings account for a quarter of all emissions in Singapore.

He added: "We have to step up green building efforts as part of the overall global effort to tackle climate change.'

Conserved buildings: Consult public before slicing and dicing

Physical landmarks help people identify with their city and give them a sense of identity and solidarity

Since 1924, the Ellison Building has stood at the foot of Mount Sophia, a landmark for this area that used to be Singapore's Jewish quarter.

But a corner of this conserved building will soon be cut off to facilitate the construction of the North-South Corridor, a 21.5km expressway that will connect towns in the north to the city. The demolished portion, comprising one of nine units, affects house numbers 235, 237 and 239. The corner will be rebuilt once the corridor is completed in 2026.

Many in the heritage community have slammed the decision to demolish and reconstruct the Ellison Building, describing it as a regressive move. Architectural conservation specialist consultant Ho Weng Hin says: "It sets a precedent and sends the message that our conserved buildings, which are legally protected, can be subjected to this type of drastic

intervention." But as Singapore Management University (SMU) heritage law expert Jack Lee had observed, the conservation scheme here does not work to restrict the Government. If the Government wanted, it could grant permission for works despite the conservation order or even delist the building.

What the conservation scheme does prevent is intervention by private property owners that affect conservation properties, without the permission of the authorities.

In the last few months, several other historic structures have had bits sliced off to make way for transport networks. A knoll that used to house the graves of Parsis, an early Indian community, was levelled earlier this year to facilitate the construction of the new Shenton Way Bus Terminal. It was part of the Palmer and Hill road area, where Sir Stamford Raffles hung the body of a merchant in chains after he had stabled Colonel William Farquhar in 1823. Scholars believe the site was important and home to a thriving community.

Next to it, the annex buildings of Bestway Building, will be demolished as part of the construction works for the Circle Line's Prince Edward station. The main block of Bestway Building, the former Singapore Polytechnic

building, is not affected, and is under study for possible conservation. The former polytechnic was home to Singapore's first architecture school. Some in the architectural community believe the site should he keprintact to be better understood as a school compound.

What that could mean is that while the Urban Redevelopment Authority may bandy about the figure of 7.000 conserved structures on this small island, there remains a risk that these buildings - or parts of them - will be sacrificed to future development

THE ELLISON BUILDING

Back in 2008, when the URA gazetted the Ellison Building for conservation, it noted the Star of David on the building's facade as evidence of the early Jewish presence in the area, and that such buildings "bear social importance in reminding us of the communities that settled here"

The Ellison, a two-storey structure with two distinctive domes and balconies, stands at the corner of Selegie Road and Bukit Timah Road. It has served as a landmark for many years.

URA conservation guidelines also state that the fundamental principle of conservation, applicable to all conserved buildings, is "maximum retention, sensitive restoration and careful repair". The decision to chop off a chunk of the Ellison has therefore puzzled many.

It has raised hard questions about the URA's role as protector of the country's heritage, and the efficacy of a conservation gazette. The Singapore Heritage Society's (SHS) executive member, Dr Yeo Kang Shua, says the decision goes against the spirit of the law and makes a mockery of the conservation gazette.

Mr Ho, the architectural conservation specialist consultant, agrees and says planners should be avoiding, not cutting through, protected buildings.

The International Council on Monuments and Sites (Icomos) Singapore, part of the international Icomos Unesco advisory body, says the move negates the critical role of heritage conservation in Singapore's national planning agenda. It adds that the decision undermines decades of painstaking efforts by state agencies, building owners heritage stakeholders, professionals and builders, and the progress in conservation achieved so far.

Another point of contention is the decision to reconstruct the demolished portion. SHS described reconstruction as

"Only in an extenuating situation, where it is unavoidable and necessary for the larger benefit of the community, that a considered decision may be taken to allow reconstruction as a last resort," he says.

He adds that planning for Singapore's land use and urban development is about overcoming fine balance between conserving the country's physical heritage and supporting infrastructure or development needs.

Describing the step of reconstruction as an exceptional course of action, he says this decision was only taken after the agencies concluded that it was not feasible to completely avoid Ellison Building in order to "realise an important national infrastructure that will serve the larger public

Dr Yeo agrees. "It involves everyone because a protected building is a public good... So there must be some mechanism for the community to protest and object.

This approach has worked here before. Take the case of national monument Tanjong Pagar Railway Station. In October last year, LTA announced that parts of its platforms would be making way for the construction of the underground Cantonment Circle Line station. What differed in its approach was that it sought advice from the heritage community on possible solutions for the two affected parallel stretches. This was after an internal study by an architectural conservation specialist consultancy engaged to assess the heritage significance and condition of the former railway station and advise on mitigation

The station was gazetted by the National Heritage Board in 2011, alongside two 80m stretches of the platforms. The remaining 350m on each side were not part of the gazette.

The case of the national monument was handled with great care, But all protected buildings should be given a fair chance to be retained holistically - not just national monuments.

This can be objectively discussed via heritage impact assessments - a tool that helps governing bodies to identify mitigation measures and options to minimise damage to buildings affected by development.

This would make for a more consistent approach.

Experts believe that the public should be engaged, alternative proposals solicited, tabled and discussed to open up the range of options available beyond the confines of bureaucracy where the main priorities are cost and speed.

It is important that decisions are made collectively as opposed to the more convenient top-down approach. Along with that, must come a change in mindsets so that the needs of one agency do not outweigh others, adds Mr Ho.

Government agencies must realise that heritage – both built and natural - is a public good as it gives a country its character. Roads do not. and neither do tunnels.

The cities of London, New York and Paris have managed to shape. themselves into thriving hubs where massive transport networks run under centuries-old buildings.

How people identify with their city and heritage leads to a sense of identity, solidarity, and urban resilience, says Mr Ho. "Once you see the weight of that, it goes beyond brick and mortar.

In that light, there is a need to carefully consider what we want to leave behind for future generations of Singaporeans.

Angelene Chan: Architect

WHETHER at home or in the workplace, family matters to Angelene Chan. She grew up in 1970s Johor Baru, surrounded by dozens of extended- family members who all lived within a stone's throw of each other in houses built around a landmark church. Now, as CEO of **DP Architects,** Ms Chan is head of a home-grown architecture family - the largest in Singapore and currently ranked 12th in the world by British architecture website *Building Design*. You could say she practically grew up in DP, having spent half of her 52 years at the firm behind high-profile projects such as *The Dubai Mall, Resorts World Sentosa* and *Esplanade Theatre*. **DP Architects** started in 1967 with 18 staffers and now employs over 1200 people in 16 offices worldwide. It's a big family to take care of, but Ms Chan wouldn't have it any other way.

You wanted to be an architect from the time you supervised your own home renovation when you were barely 12. Why? And how is running a big company different from simply practising what you love? I just love design. This profession allows me to push the boundaries of my imagination. There are big jobs, but I've always continued working on the small ones - they are the ones that make you pay attention to the little details. My role is to propel DP to the next league globally, but it's not just a management role - I'm still very much involved in design. We are a big firm and we have to aim for design excellence all the time - we're proud to be a Singapore brand.

There's also a close-knit kampong spirit that is a significant aspect of the DP philosophy. Which is no doubt what you grew up with. Any memories to share? My grandparents, parents, uncles, aunts and many relatives lived on land surrounding the Church of Immaculate Conception at Jalan Ngee Heng in JB. My family has been there since the 1930s; It was a happy place to live and grow up in; full of warmth, sincerity and laughter. Those were my formative years and there were always friends and relatives close by, visiting or eating in each other's homes. There were about 20 houses - half belonged to relatives but all of us were friends. There were never any fences between our homes. My grandfather had the first TV in the neighbourhood. Many kids would show up, unannounced but always welcome. I remember watching Happy Days and thinking that my dad was cool for being like 'The Fonz' - he wore his hair like Fonzie for many years. Football was big in the neighbourhood. The Dolphins Football Club was one of the best teams in the local league. Everyone either played or watched football, or gathered at after-match parties for satay and beer. I grew up believing that after family and religion, comes football! Back then, people looked out for each other without having to be asked. These same values drew me to **DP Architects** when I first applied for a job in 1990. It was my first job in Singapore and I have stayed ever since, largely because I feel a similar kampong spirit here. My father moved to Singapore years ago, but before he passed away this year, he told us that he wanted to have his wake in our original house next to the church. To have the wake there was very meaningful - plus I half-wanted to see the house I renovated again.

You were appointed CEO in January 2016. What's your approach to running a large firm? There are a lot of mouths to feed. We believe in family and it's a big responsibility, that's why when there's an economic downturn - business is extremely slow this year, and maybe next year as well - we don't downsize. We may cut salaries from the top down. Over five recessions, we'd rather keep the firm together through cost-saving measures than by letting people go.

You collaborated with *The Food Explorer Group* to open Redpan, a casual eatery in Marina Square - where your office is. What possessed you to go into the food business? We see it as an experimental place for us to showcase our design. We're not just about big malls or sports hubs - we do other things as well. 



AWARDS & DESIGN COMPETITIONS



The International Union of Architects (UIA) is delighted to launch the second edition of the 'Friendly and Inclusive Spaces' Awards. The awards recognise and promote inspiring examples of inclusive design – from buildings and public spaces to research. The winners will be announced at the UIA World Congress in Seoul in 2017 and will benefit from international recognition and publicity. Administrated by the Royal Institute of the Architects of Ireland, the awards are open for online entry from 28 September to 20 December 2016. It is simple to enter - follow the steps below.

ELIGIBILITY AND ENTRY

Eligible are built works designed by architect member(s) of **UIA Member Section** that have been completed since 30 November 2013. Works may include: new buildings and public spaces, and rehabilitation or adaptive reuse of existing or historic buildings and places. A special award will be given to an architect(s) for evidence-based design research that makes a significant contribution to improved quality of life through facilitating a better understanding of user-centred design and its application to the design of the built environment.

The 'Friendly and Inclusive Spaces' Awards are hosted on the online platform Awards Force, where projects can be entered on:

There is a fee of €50 for Stage 1 entries and a subsequent fee of €150 for Stage 2 to facilitate the printing of exhibition panels. Following short-listing by regional juries (Stage 1) an international Jury (Stage 2) will decide on the winning projects. The winner of each category will be announced at the UIA World Congress in Seoul in September 2017.



Developing young people's awareness of architecture, the city and sustainable development is an urgent and vital challenge. With access to knowledge in these areas they will be able, as adult citizens, to make their voices heard and influence the political, economic and social strategies, which will shape their cities and their environment.

The Awards will honour people and organizations that help children and young people to understand architecture. Entrants will be invited to submit entries describing activities or products designed to teach children and young people, from pre-school up to and including the age of 18, to understand architectural design and the processes by which our environment is formed.

THERE WILL BE AWARDS FOR SCHOOLS, INSTITUTIONS, WRITTEN MEDIA AND AUDIO-VISUAL MEDIA. The UIA Architecture and Children Work Programme announces the launch of the

UIA Architecture & Children Golden Cubes Awards 2014/2017



The **UIA Architecture & Children Golden Cubes Awards** process is not a 'competition' for which Entrants are expected to produce new projects. Instead they are invited to present submissions relating to an activity which is currently active, or to a product produced, or an event which has taken place, at any time between August 2014 and the submission deadline of 15 March 2017.

THE AWARD PROCESS HAS TWO PHASES. IN THE FIRST PHASE each UIA National Member Section participating in the Award will organise a selection process at National level and nominate one entry for submission for the International Awards. IN THE SECOND PHASE the UIA Architecture & Children Golden Cubes Awards International Jury will evaluate the Nominated Entries and select one in each category for an Award.

The Awards will be presented and the winning and selected entries exhibited at the **26th UIA Congress** in Seoul / Korea, September 2017.


