"Building Stewardship Locally and Globally"

Mr. Larry Eighmy, Founding and Managing Principal of Stone House Group, will present the vision of "Building Stewardship" by aligning facilities and master planning stakeholders at the conceptual stages of a project. Larry will present insights and quantifiable benefits of energy and water savings, CO2 and solid waste reduction, daylighting, tenant retention, and return on investment. Several case studies. from both Asia and the United States, will highlight the benefit of "Building Stewardship" in educational and corporate facilities.

"Green Labeling Scheme, Product Endorsement and Cost Savings Strategies"

With all the talk about green products, green buildings and green businesses it has become ever more prevalent for both domestic and commercial consumers to seek validation for the claim made by both organizations and products Singapore Green Labelling Scheme has been established to compare, assess, and validate the claims of products marketed locally thereby providing them with a certified endorsement of their environmental impact. The benefits gained through Eco-Label certification lends not only credibly to the endorsed products but also acts as a tools for private and public sector companies to develop tenders thereby greening their supply chains. Added benefits of ecofriendly products, contrary to popular misconception, yield financial savings via their inbuilt abilities of increased performance, efficiency, rigidity, resource conservation, embodied energy, carbon footprint, etc. In addition, eco-labelled products are also used to validate the eco-friendly attributes of construction projects thereby acquiring certification under programmes such as LEED's.

Ltd after Chengdu's May 2008 earthquake, which focused on sustainable design of 200 schools in Sichuan province, and a targeted LEED Platinum for the iconic Beijing's ParkView Green. Mr Eighmy is a Trustee for Moravian Academy and sits on the Advisory Committee of

Saucon Valley Conservancy. Mr Eighmy attended Middelbury College, Carnegie Mellon University, Graduate School of Industrial Administration and Harvard University Graduate School of Design.
