# 1) Mr Tony Ang

Tony Ang graduated from the National University of Singapore in 1981. Tony is the Managing Director of Aedas Pte Ltd. He is currently a council member with the Board of Architects and also chairs the SIA Road & Transport Sub-Committee on LTA matters. He is also a registered Fire Safety Inspector. Tony has worked on several prominent large projects over the last 30 years namely Nee Ann City, One Raffles Link / CityLink Mall, 313@Somerset and Marina Bay Integrated Resort.

## **Presentation Topic:**

Marina Bay Integrated Resort - Statutory Trail

The Marina Bay Sands Integrated Resort is a very large and complex project and has a wide scope of Statutory Submissions. This presentation will cover a range of statutory issues that are not normally addressed for other projects.

# 2) Mr Warren Liu

Warren Liu was a former Associate of DP Architects Pte Ltd. In year 2000, he came out to help set up DLab 3, a small experimental design outfit that focuses on cutting edge residential projects that tackle the issues of social and economic transformations within high density urban living conditions. He has since acted as design consultant for DLab 3, which has been run by his partner, Darlene Smyth. He joined Nikken Sekkei as a Design Principal between 2001-2003. Nikken Sekkei partnership was subsequently dissolved toward the end of 2003 and to facilitate the transition of projects handled by the office, WOW architects was formed with Warren as one of the founding partners where he also acted as the Design Director of the associated firm Warner Wong Pte. Ltd., which focuses on interior design projects.



In 2007, he left to focus on the development of DLab 3 (now renamed DLab) which has become a researchbased practice, centered on creating new or emergent experiences by addressing the specific site, economics and programme of each individual project. Approaching the site in a diagnostic manner, he works with the given body and makes sensitive alterations where necessary to improve its sustainability, without performing any radical surgery that removes existing functional organs within a system.

# 3) Mr Chin Thoe Chong

Mr. Chin Thoe Chong graduated with honours from the National University of Singapore in 1987. He joined the firm upon graduation and has been with DP Architects since. He was made a Director in 1998.

He has been involved in a wide spectrum of projects ranging from landed and high rise residential developments, Master Planning and interior architectural design, institutional and large scale mixed use commercial developments. He focuses in the dual management of design and project administration for projects in Singapore, Malaysia, China, Dubai and the region.

Mr Chin is a member of both the Singapore and Malaysian Institute of Architects.

# Presentation Topic:

Resorts World Sentosa comprises 7 separate hotels with approximately 1,400 guestrooms, 3 family theme parks -- Universal Studios Singapore, a Marine Life Park and a Water-theme park -- above a two-level basement car-park. Other attractions include over 60 F&B restaurants and food outlets, Maritime Experiential Museum and perhaps one of the region's largest Aquariums. Covering a site area of just 46 hectares, the project has a built-up GFA of 343,000 sq.m. Phased into two stages, the Resorts World's Master Plan will complete in its entirety by early 2012 – just four years after construction started.

The size, scale and complexity of the project demand an unconventional approach in the administration of the processes from design conception to the construction of the eventual built forms. The talk will focus on some of the key issues related to local urban design and planning guidelines, the resolution and negotiation of possible solutions from the concept proposal and finally, the challenges of working on a complex large scale development.

# 4) Mr Mohd Asaduz Zaman

Mohd Asaduz Zaman, is one of the most senior architects in Surbana International Consultants Pte. Ltd. with 36 years of experience. He started his career as an apprentice in the office of Louis I Kahn, a World-renowned architect. After getting his Master's Degree in Architecture in USA, he joined Housing & Development Board of Singapore (HDB) as an architect in 1974, and later became Head of Architectural Design Studio. He has been the designer for many renowned Housing, Commercial and Mosque projects in HDB Towns. His contribution to new Design direction and Architecture has been very valuable especially in Bukit Panjang and Punggol Town. His strong sense of design is evident in producing award winning designs in Singapore and overseas, such as FIABCI and SIA Awards. Since 2003, he has been tasked to head a large team of Architects and as a Design Mentor in Surbana.

## **Presentation Topic:**

30 Jalan Rukam - Green Living In Urban Singapore

30, Jalan Rukam is a semi-detached that has been designed to create an open all-round tropical living space within the semi-detached envelope, interacting with its neighbour spatially and visually. The space flows from one to other, 'wall-ed' by landscape, 'ceiling-ed' by tree canopies and the sky. These spaces are surrounded by tropical plants and trees, allowing one to experience being in an outdoor space with lush greeneries, reminiscent of rain forest.

Humble-looking from outside, the feeling of openness and vastness is a delightful surprise experienced only as one enters the house.
