SYNOPSIS

When planning or designing a city, building or house, one should always consider including art.

A common question that is raised when discussing the integration of art with architecture, is whether there is a difference? Isn't architecture considered art? Award winning architect, Richard Meier is quoted as saying, "Architecture is the greatest of the arts".

We distinguish between three ways of incorporating art with architecture:

1.Design the building or house in an artistic way, almost as a sculpture.

2. Merge the building or house with the environment and landscape.

3.Add works of art indoors and out.

Although these three agendas are distinct, we often see a merging of two and sometimes even all three of them.

Some artists and architects will also incorporate the forces of nature into their creations. One example is making use of the sun's rays and trees.

We will present these agendas in our lecture along with examples and ideas.
