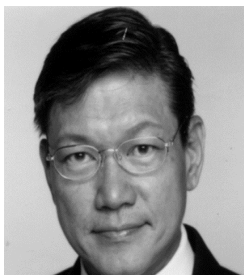

SYNOPSIS

Fire Code Requirements For A&A Works In Singapore Public Housing

Singapore public housing estate have evolved over the years from providing basic housing needs to one which provides a good housing environment and lifestyle. The older estates are also going through transformation. The lifts are upgraded under LUP scheme to meet better lift ratio for the aging population. Other upgrading scheme such as Neighbourhood Renewal Programme (NRP), Revitalization of Shops Scheme (ROS), Main Upgrading Programme (MUP), Interim Upgrading Programme (IUP), Lift Upgrading Programme (LUP) etc are in place to meet the new environment. This paper intends to address fire requirements in the public housing estate upgrading scheme and also change of use of existing commercial usage by their owners.

PROFILE

Mr Koh Tien Beng has more than 30 years of experience in architectural practice in Singapore. He is an active member of The Singapore Institute of Architects' Fire Safety & Security Sub-Committee since 1996 and was Chairman of the committee from 2001 to 2005. He was appointed as a FSSD Registered Inspector since November 1994. Besides being a member of the Fire Safety & Security Sub-Committee, currently he is also a representative of the following committees :

- a) FSSD Standing Committee c) FSSD RI Waiver Committee
- b) FSSD RI Enquiry Panel d) Research Study Group for effective building design for prevention of vertical fire spread – air well.

As a Registered Inspector, Mr Koh had conducted inspections to many new private and public projects. Over the years, he had also inspected various types of HDB upgrading projects e.g. MUP, IUP, LUP, ROS etc.
