This year BCA intends to roll out a series of amendments to Building Codes and Codes on Accessibility in the Built Environment. In addition, there will also be updates to Code of Practices on Buildability and Environmental Sustainability. It is therefore timely that architects keep themselves abreast with these impending changes that will affect their design in a very direct and uncompromising way. The SIA Building Control and Parks Committee is please to have three representatives from BCA who are directly involved in these areas to brief members on these impending changes, to share their experiences and to help members be prepared for the challenges ahead.

Members of our SIA Building Control committee also attend weekly BCA Waiver Meetings. We saw waiver applications that were rejected regularly under situations that were discovered way too late in the design process. As a result they are difficult to salvage and often have to resolve at great effort and expense. Frequently these unpleasant non-compliances could have been avoided had the architects be more aware of the code requirements. Able to relate to the code requirements throughout the design processes is the key to avoid surprises at the TOP. Members of our Building Committee are pleased to share with architects a "live" tool that would help them in this process.
