## **Developments in Adjudication and Security of Payment**

Architects certify, and may even assess and verify payment claims. This seminar will provide participants with an update in relation to adjudication claims under the Security of Payment Act. It will cover the latest 2013 cases such as WY Steel, Shin Khai, Australian Timber Products, Admin Construction and Tan Poh Eng Construction.

The implications of these latest decisions on consultants and their duties and responsibilities will be discussed.
