Update on New Form of Contracts

The SIA Building Contract Sub-Committee has been working on a new version of SIA Building Contract since September 2011.

The main features of the new version are to retain the spirit of the Duncan Wallace's provision, to pro-business, to be in plain English and to avoid dispute by identifying and allocating risk to parties for them to be priced in their tender. Also, international versions of the new contract have been drafted for works outside Singapore.

A seminar on the introduction of SIA New Building Contract has been conducted on 24 October 2013. The Sub-Committee is presently collecting feedback from the membership.
