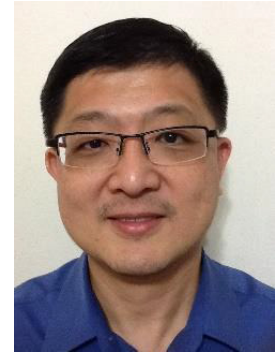






## TRAINERS
