Project: House at Neil Road Mr Mark Wee, Ong&Ong

Mark Wee is the Director of the Experience Design studio at ONG&ONG.

He works with clients to establish its story and strategy for memorable experiences that emotionally engage its users and impacts culture. The studio takes a transdisciplinary approach in designing how people, places, and technology come together across the fields of architecture & interiors, branding & communication, and service design, framed by a design thinking approach centred on understanding human motivation and behaviour. Mark has a passionate belief

that design can be a currency for transformation, and should serve others to make life better.

This has led to the designing of innovative award winning experiences such as OCBC's award winning Gen-Y bank Frank, SGX's workplace & public experience, and Singapore Airline's new Silverkris Lounges' 'Home Away From Home' concept world wide.

Also an award-winning architect, Mark's projects have won design awards such as the URA Heritage Award & the Singapore Institute of Architects Design Award for The Majestic Hotel in 2006 under DP Architects, and most recently, the URA Heritage Award for 145 Neil Road in 2014.

Mark has served as a Council member of the Singapore Institute of Architects since 2009, and is also an artist and illustrator. The practice's first book entitled 'Let's Experience Design' will be available in bookstores at the end of the year.



### Project: riceLAB Mr Chioh-Hui Goh, Studiogoto

Chioh-Hui Goh is one of the two founding Principal Architects of studiogoto. He graduated with a Bachelor of Architecture (Hons) in Year 1992 from the National University of Singapore, and was awarded a Distinction in design. Prior to studiogoto in 2009, he had practiced for 16 years in several acclaimed architecture practices in Singapore where he led the design directions of numerous projects that eventually went on to win many design awards in both the local and international architecture scenes.



### Project: Deck Mr Ho Tzu Yin, Laud Architects

Ho Tzu Yin is one of the founding partners and Deputy Managing Director of LAUD Architects Pte Ltd. A Registered Architect with the Board of Architects (BOA), Singapore, he obtained the First-Class Honors for Bachelor Degree in Architecture from the Royal Melbourne Institute of Technology (RMIT).

Besides engaging in professional practice, Tzu Yin had served as Panel Member for the Singapore Polytechnic (SP) School of Design and Architecture 5-yearly Academic Course Review, served as a Design Studio Tutor (Part-time) in National University of Singapore (NUS) School of Architecture and Built Environment, and is

also a member of the Singapore Institute of Architect (SIA) BIM Interest Group (BIG).

Tzu Yin has experience in a diverse portfolio of projects ranging from condominiums, institutional buildings, place of worship, private residences, etc, many which has received Design Awards including SIA Design Awards and shortlisted for World Architectural Festival (WAF).

Tzu Yin believes that good architecture must incorporate three aspects: First, it must appeal to the intellect, meaning the architecture must be capable of communicating through a conscious understanding and interpretation of its composition of forms and volumes to the visitor. Secondly it should fulfil its role as a social institution that supports the daily social interactions of the occupants. Thirdly it must offer a heightened sense of experience, whereby a memorably designed space transcends the mundane quality of daily life.
