Other ongoing major initiatives that Practice Thrust will strive to accomplish are to develop a Practice Management Framework (PMF) to address work practice, business and risk management relevant to the practice of architecture, to organise Fire Code Workshop to equip the QPs with the knowledge and know-how of Fire Code, Redevelopment of NPQS to enhance its capability and suitability to keep pace with the rapid changes in the construction industry as part of the productivity drive and to incorporate BIM and sustainability issues, Review on the scope of Basic and Additional Architectural Services to publish on SIA website, Review SIA Conditions of Appointment and Architect's Services and Mode of Payment, to publish SIA Conditions of Sub-Contract for use in conjunction with the Minor Works Contract 2012, Partnership Agreement Checklist, Monitoring those invitations published on GeBiz which call for free design in the form of submissions of drawings, design concept, sketches, concept images, etc. as part of tender evaluation, checking if such invitations are in accordance with SIA's Design Competition Guidelines, and if not, then highlighting to the relevant agencies and BCA that SIA members are not able to participate in such design competitions; to name a few.
