11.	Commercial / Association Space	Is the quantum fixed, In terms of 55% and 45%?	Yes.
12.	Multiple Entries	For multiple entries submission, do you need different QP for each entry?	1 QP can submit 1 entry only.
13.	Carpark	Any specific requirement for car park beyond LTA's minimum req?	No. The actual number of spaces required may fluctuate according to program mix. However, for purposes of the competition design, please refer to page 20 of the brief for indicative number of car parking spaces to design for.
14.	Green Mark	Any we aiming for any specific Green Mark certificate?	The client is targeting to meet Green Mark Gold standard as minimum level and will explore higher rating subjected to further advice and cost evaluation from consultants/ specialist.

19.	Multi-Disciplinary Team	Will it be a multi-disciplinary design effort?	This brief is not calling for a MDT submission. Stage 1 is strictly architectural. Stage 2 is a development of the architectural design which, for the sake of feasibility, may need schematic inputs from other consultants. However, note that the other consultants will be appointed separately by client after the successful architect is commissioned separately by the client.
20.	RIP	Will RIP be given or do competitors have to purchase it?	Road line plan in DXF and the Topo plan in PDF and CAD are provided in the competition package.
21.	Competition Package	Are all downloads available only after we pay for registration?	The competition package is available before registration and payment. Please email design_competition@sia.org.sg to request for the link to the competition package.
22.	Commencement of Design Works	Is there any timeline for commencing of design work and procuring TOP?	This will be subject to planning by appointed consultants. To note, Project is slated to complete construction by Q4, 2023.
23.	Commercial Shops	How many commercial shops is the client looking to have on 1st level?	No specific requirement.
24.	Exhibition of Entries	Will there be any exhibition or publication by client for the competition?	The client is keen to hold an exhibition on the submitted proposals after Stage 2 competition (minimally the shortlisted finalist schemes). The details and management of the exhibition (whether online or on location or through other media) will be determined later. All competitors will be duly informed by SIA.

25.	Stage 1 requirement	Please elaborate on the Stage 1's requirement on the design submission? As in the renderings, floor plans, sections and elevations required. That seems to be quite extensive and akin to almost a complete design proposal.	The deliverables are outlined as an indication. The final choice of drawings, in type and quantity, are subject to each architect's discretion. As Stage 1 is essentially seeking for ideas, please provide the necessary to communicate your design ideas succinctly.
26.	Jury Panel	Who are the architects in the jury?	Refer to competition brief section 4.9.
27.	Competition Package	Where can we get the competition brief?	Please email design_competition@sia.org.sg to request for the link to the competition package.
28.	Back lanes	The back lanes look very narrow and are blocked off by bollards. Is the intention to widen it, clear the illegal extensions and use them for basement access / service?	We are not able to comment on the legal status of structures outside the boundary for now. However please peruse the master plan, the surveyed boundary lines and to design according to the information given on the technical plans, taking up space within the plot if necessary.
29.	-	This project appears to be more commercially driven than ideas driven. Why did the client ask for an architectural competition?	The client is opening up the brief to the architectural community to seek good ideas for the mixed-use building.
30.	Mechanical Parking	Is Mechanical parking acceptable for client?	Client is open to considering mechanical parking to supplement conventional parking but has expressed concern about full adoption of mechanical parking for reasons of cost and maintenance.

31.	Building Access	Have there been any preliminary discussions with authorities, ie LTA regarding the building access?	No pre-consultation has been done with LTA.
32	Architect's Fee	Please clarify the fee of 4.2% shall be purely architect's fee excluding any specialists' fees e.g. Green mark consultant, design for safety consultant, exhibition designers, etc.	4.2% professional fee is the architect's fee and will exclude green mark consultancy, design for safety consultancy, exhibition design.
33.	Landscape	Is there any landscape requirement?	Refer to competition brief, section 3.2.4. In addition, the client is keen to qualify for Bonus GFA with Rooftop Greenery (LUSH) scheme, amongst other schemes (Page 12 of brief).
