A) BACKGROUND

A.1) INTRODUCTION AND VISION

Singapore's urban planning is evolving towards mixed-use work-live districts to optimise land use and bring jobs closer to homes. Concurrently, with Singapore's ageing population, there are heightened aspirations to age in dignity, including access to gainful employment and essential services near homes, alongside growing recognition of the value of fostering inter-generational connections.

Hence, the Client Jurong Town Corporation (“JTC”) aspires toward a new “Industrial-Residential” mixed-use building typology (“Typology”) that seamlessly integrates light industry¹ spaces with housing. The Typology shall create conducive work-live-play-learn environments within the same building, facilitate synergistic relationships between industrial companies and live-in communities, and support aspirations for sustainable, healthy work and living places. However, current regulatory frameworks and conventions for planning and design usually maintain separation between industrial and residential uses, preventing the realisation of such truly integrated developments.

Entrants are to design this innovative new Typology based on subject sites in Toa Payoh, conduct a thorough and realistic review of the technical and regulatory challenges and solutions, and propose comprehensive design guidelines for the realisation of this Typology for future sites with similar contexts.

B) SUBJECT SITES

B.1) INTRODUCTION

The subject sites for this Think Tank are purely for entrants' research purposes, to rigorously test the feasibility of entrants' proposals and to develop general guidelines for this mixed-use typology (refer to **Chapter C.1** for an overview of the development of the deliverables).

Chapter B outlines some characteristics or requirements of each subject site. For more technical requirements of the Think Tank which are applicable to all subject sites, please refer to **Chapter C**.

B.2) OVERALL CONTEXT OF SUBJECT SITES

Toa Payoh is one of Singapore's pioneering new towns, centrally located with excellent connectivity via MRT and major arterial roads. The estate is characterised by a mature, multi-generational community of elderly residents alongside young families of working professionals and schooling children. Notably, the estate already features a mix of residential and industrial uses in close proximity, providing a realistic and relevant testing ground for understanding how the proposed Typology can integrate existing community infrastructure while fostering vibrant, inclusive communities that bridge traditional boundaries between industrial and residential life.

B.3) SUBJECT SITE 1

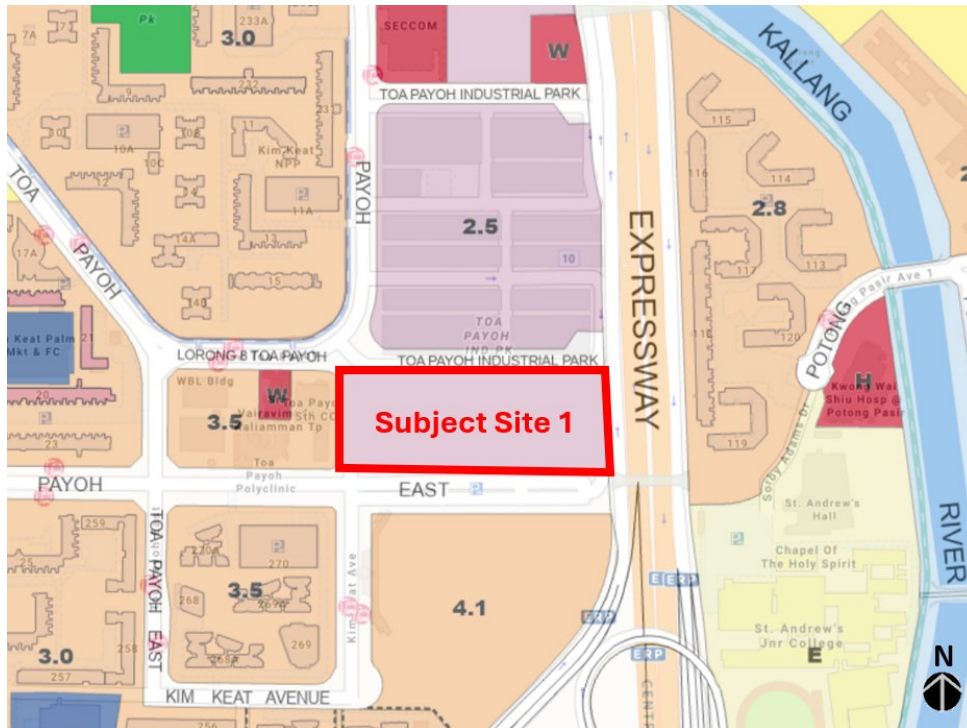


Fig. 1: Indicative boundary of Subject Site 1 in red. Plan extracted from URA Master Plan, with adjustments made to site boundary for purpose of this Think Tank only.

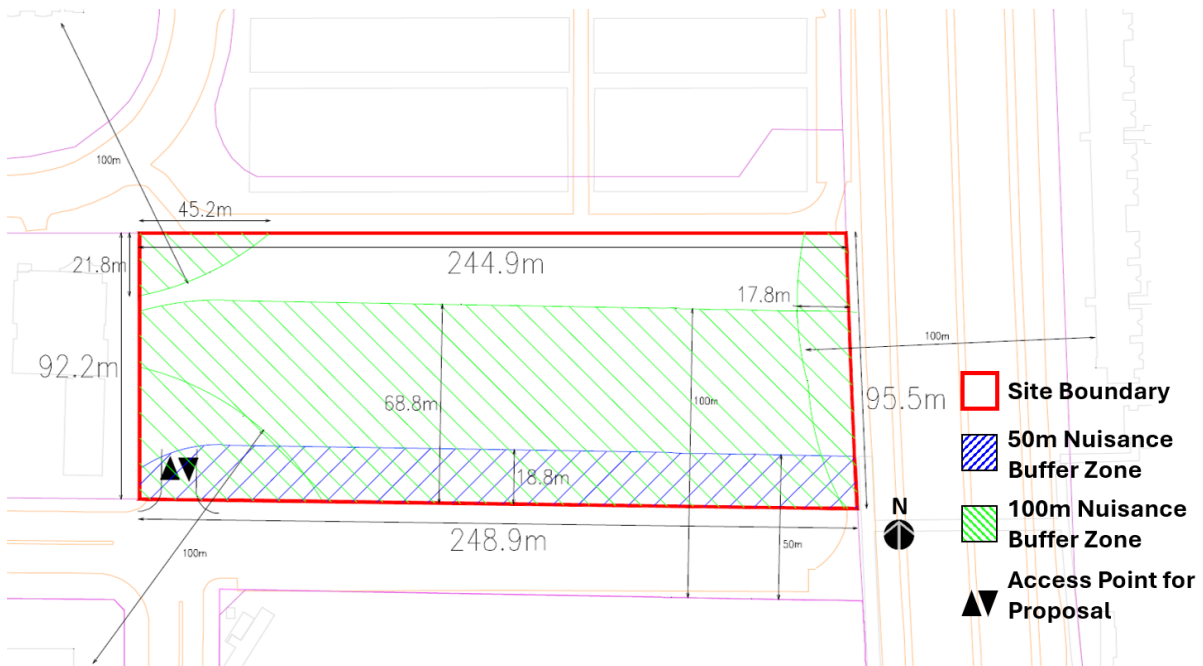


Fig. 2: Dimensions and other key planning parameters of Subject Site 1, for purpose of this Think Tank only.

Subject Site 1 is part of the existing Toa Payoh Industrial Park. It is Business 1 (B1) land use zoning, and about 2.3ha large.

Notable features of the surrounding context include:

- a. Other Industrial Business 1 (B1) plots to the north, which consist of flatted factories and terraced workshops.

- b. Residential blocks ranging from older HDB flats in the northwest to future BTO HDB flats to the south.
- c. Existing community facilities such as Toa Payoh Polyclinic and Toa Payoh South Community Club to the west.
- d. The Central Expressway (CTE) to the east.

Subject Site 1 is flanked by public streets to both the north and to the south, lending the site the opportunity of having unique public frontages responding to the different neighbouring uses, and allowing the proposal to act as a transition zone between the surrounding B1 plots, Residential plots, and existing community facilities. The proposal shall also consider how to buffer the residential spaces within and around the site from CTE, to reduce disamenity to residents.

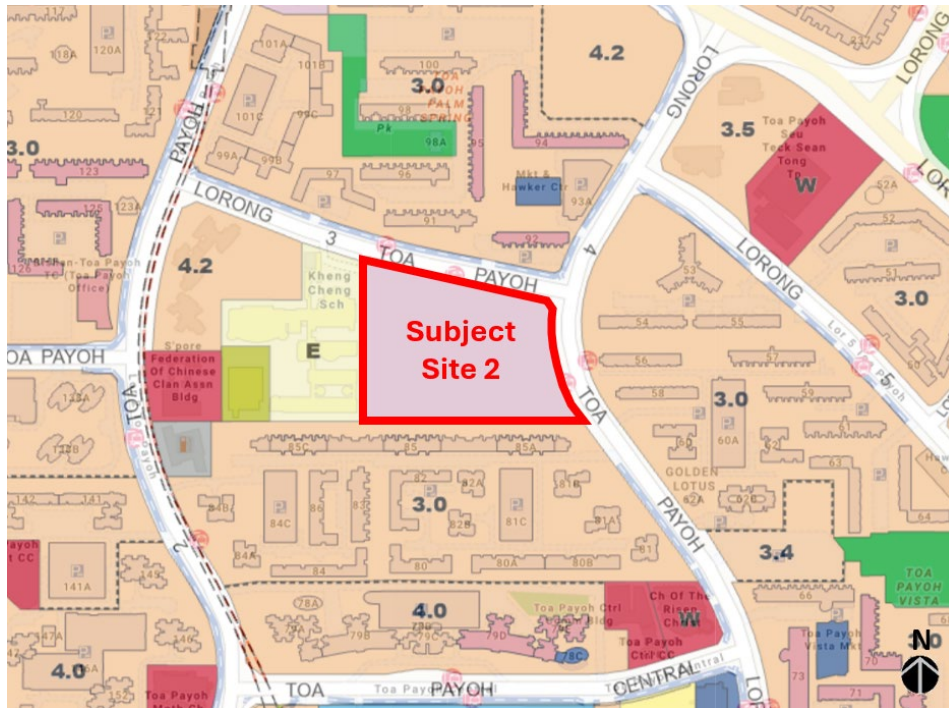


Fig. 4: Indicative boundary of Subject Site 2 in red. Plan extracted from URA Master Plan.

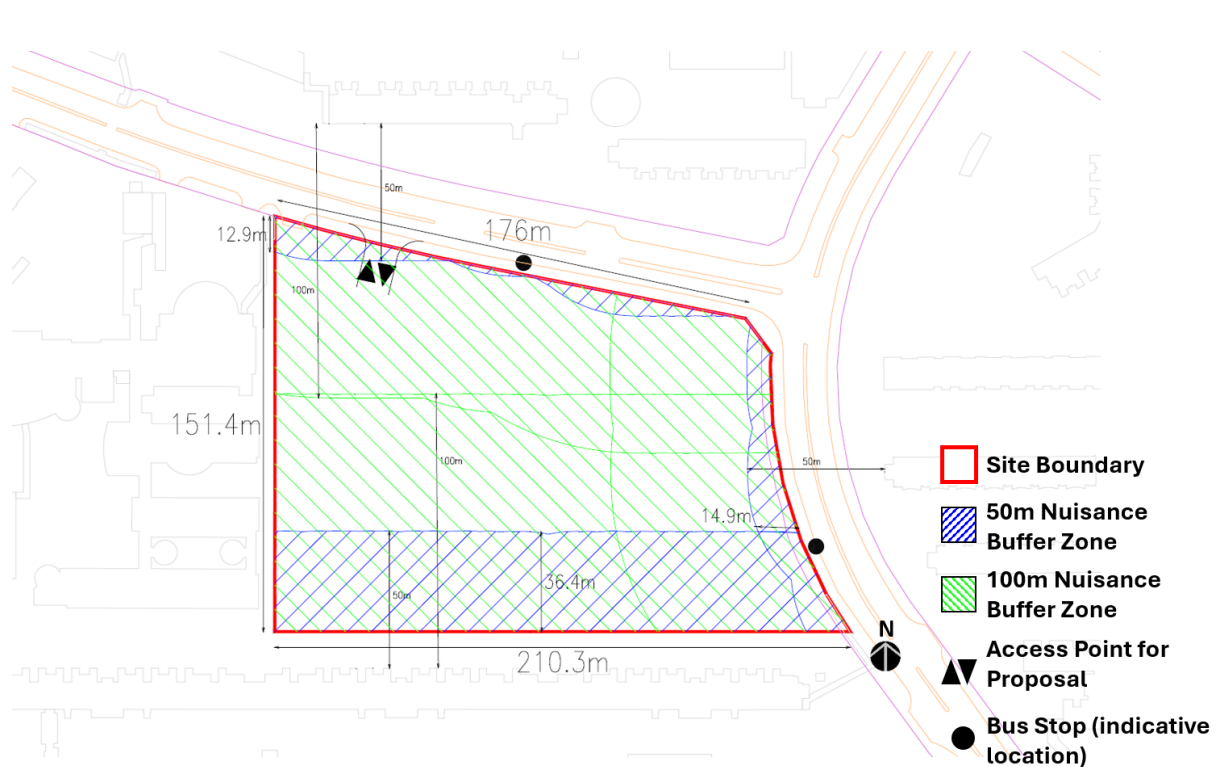


Fig. 5: Dimensions and other key planning parameters of Subject Site 2, for purpose of this Think Tank only.

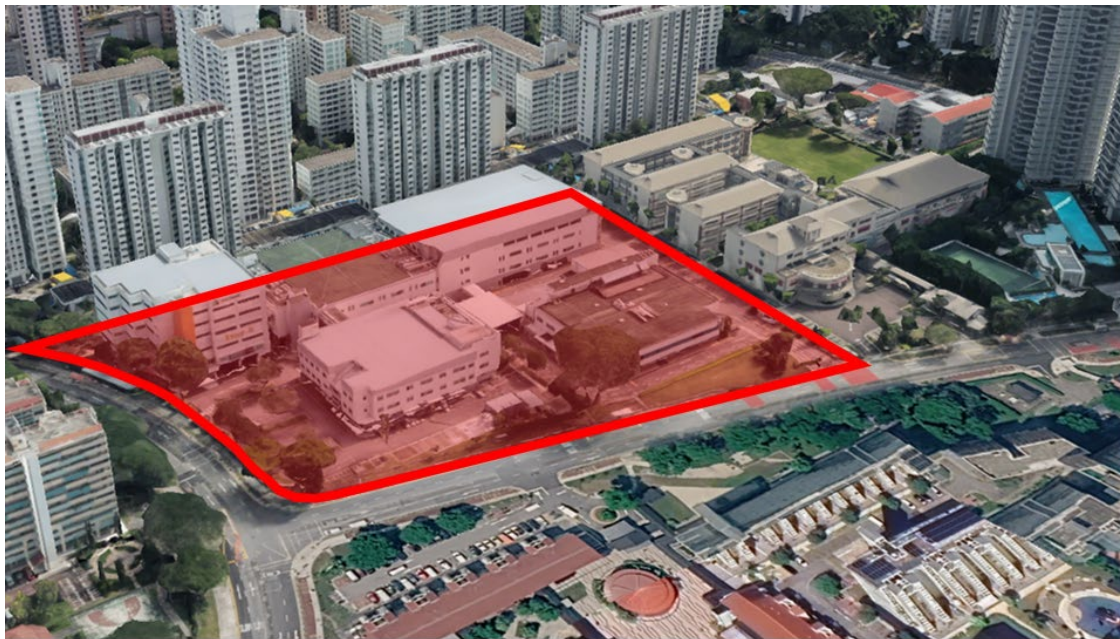


Fig. 6: Indicative boundary of Subject Site 2 in red

Subject Site 2 is located within the Toa Payoh residential neighbourhood. It is Business 1 (B1) land use zoning, and about 2.4ha large.

Notable features of the surrounding context include:

- a. Residential blocks ranging from HDB flats to existing and future condominiums. The residential blocks are generally low-rise along Lorong 3 Toa Payoh, and high-rise at the south of the site.

- b. Education Institutions such as Kheng Cheng School to the west.

Subject Site 2 is flanked by public streets to both the north and to the east, and is surrounded by neighbouring Residential plots on most sides. The site is in close proximity to a school, which gives the subject site the opportunity to contain facilities which may be shared with students and/or teachers, and industrial or work spaces capable of actively engaging both young and old residents.

C) TECHNICAL REQUIREMENTS

C.1) OVERVIEW

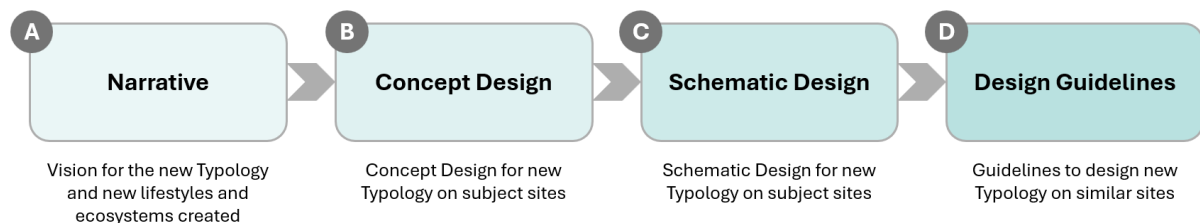


Fig. 7: General flow of Stages for the Think Tank

Entrants should bear in mind that the main objective of the Think Tank is to conceptualise a new Industrial-Residential building typology which could be implemented on more sites beyond just the subject sites used in this Think Tank. Hence, the various stages of the Think Tank as outlined in Fig. 7 above illustrate the progression of the Typology's creation through narratives, then concept and schematic designs on the test subject sites, and finally the distillation of findings from the earlier stages into design guidelines that allow the Typology's future implementation on other sites in general.

Creativity, innovation and thinking beyond the current regulatory framework, where necessary, is fundamental to envisioning the future of Singapore's polycentric city. To do so, entrants are expected to be conversant in the current technical and regulatory constraints in order to propose insightful and realistic changes to the relevant constraints and codes. The rest of **chapter C** will outline the key considerations and requirements that would guide the proposals from concept to potential roll-out guidelines.

For specific deliverables at each stage of the Think Tank, refer to **chapter D.2**.

C.2) KEY CONSIDERATIONS

1	Land Optimisation The Typology must maximise development potential through innovative spatial arrangements that integrate light industrial and residential uses within constrained urban footprints.
2	Keeping Industries Relevant to Neighbourhoods, Integrated through Good Urban Design In line with Singapore's polycentrism strategy, the Typology should create new economic nodes that bring essential services closer to residents, and contribute positively to neighbourhood character through attractive public interfaces and community spaces.
3	Programmatic Synergy, Flexibility and Community Engagement The Typology's programmes should foster synergistic relationships between light industrial and residential communities, creating opportunities for collaboration and mutual benefit, while allowing spaces to be flexibly used across different times of day for varying user groups.
4	Space Planning and Nuisance Management Proposals should demonstrate horizontal and vertical integration strategies, addressing relevant authority requirements and proposing changes where needed to enable compatible light industrial and residential functions to coexist.
5	Demographic Diversity and Accessibility The Typology must serve diverse demographics, creating conducive work environments that attract young talent while facilitating aging-in-place for elderly residents.
6	Futureproofing Diverse Life Cycles

	The Typology must accommodate the different real estate cycles, such as the typical 20 to 30-year industrial leases, shorter commercial tenancies, and longer residential tenures, and propose the approach towards addressing the different redevelopment and ownership models and timelines.

C.3) NOTABLE SPECIFIC REQUIREMENTS

I. Regulatory Review and Recommendations

Given the intent of this Think Tank is to innovate a new typology, entrants must conduct a comprehensive review of existing authority compliances that pose challenges to the proposed Industrial-Residential Typology's implementation. This review should identify specific regulatory barriers and recommend realistic changes to codes or requirements by relevant authorities, alongside implementable mitigation measures. The regulatory review shall minimally include codes or requirements under the Urban Redevelopment Authority (URA), National Environment Agency (NEA), Singapore Civil Defence Force (SCDF), Land Transport Authority (LTA), Building Construction Authority (BCA), NParks, Singapore Green Building Council (SGBC), and Ministry of Manpower (MOM).

II. Light Industry, Residential, and Ancillary Spaces and Programming

While no specific schedule of accommodation is provided, entrants are expected to propose comprehensive programmes that must integrate light industry production/manufacturing spaces with residential units and ancillary facilities. Proposals must include detailed descriptions and examples of the proposed light industry activities, including explanations and justifications of why such light industry activities were proposed. Ancillary spaces proposed should complement the proposed innovative mix of uses and programmes.

Entrants may refer to quantum guidelines under Development Control guidelines, but should explore innovative spatial arrangements and quantum distributions that challenge existing regulatory frameworks, where necessary to fulfil the vision of new ecosystems and lifestyles for the Typology.

D) THINK TANK SUBMISSION, PRESENTATION, TERMS AND CONDITIONS

D.1) INTRODUCTION

The Singapore Institute of Architects (SIA) has been appointed by JTC to organise this Think Tank to invite proposals on the narrative, design, and design guidelines for a Industrial-Residential Typology.

This is a multi-stage study with progressive shortlisting of entrants between different stages, and with different deliverables and submission requirements at each stage (refer to **chapter D.2.II**).

The law governing the conduct of this Think Tank shall be Singapore Law and the language of the Think Tank will be in English. This Think Tank shall be subject to the terms and conditions set out in **Chapter D.1 to D.17**. Unless the context otherwise requires, capitalised terms used in **Chapter D.1 to D.17** shall have the meanings ascribed to them in **Chapter D.15**.

D.2) THINK TANK SCOPE, SCHEDULE, AND SUBMISSIONS

I. Overview

The subject of this Think Tank is the provision of a design for the new Industrial-Residential Typology, as described in the Think Tank Brief (specific deliverables for each stage of the Think Tank are set out in **chapter D.2.II**). It is important that the design should fulfil the objectives set out in the Think Tank Brief. The ideas should demonstrate an understanding of the requirements of the Typology, including the relevant regulations, opportunities, constraints, and the urban and social context of the subject sites.

Entrants must keep the Think Tank schedule in mind and the shortlisted entrants must competently manage the time and resources available for research, design development, technical design, co-ordination, and documentation and preparation of deliverables.

Submissions at the “Narrative” stage must not bear any motto, logo or distinguishing marks of any kind to identify the team and its members submitting the design.

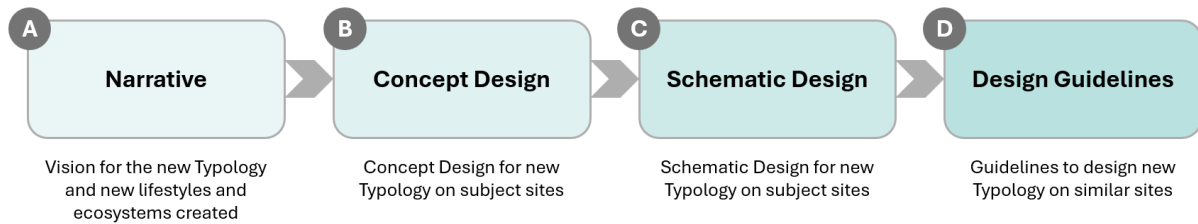


Fig. 8: General flow of idea and design development for each stage of the Think Tank

There are four Stages to the Think Tank as outlined in **Fig. 8** above.

Advisor(s) may be appointed for the Think Tank. The Advisor(s) may provide consultation sessions to shortlisted entrants during Stage B, and Stage C, drawing on their relevant experience to provide comments and critique that help entrants develop the Typology further, in line with entrants' and the Think Tank's vision and intent. The Advisor(s) are not part of the Jury Panel deciding shortlisting outcomes.

The table on the subsequent pages outlines the key dates (including Advisor Consultation sessions), Think Tank deliverables, submission formats, deadlines, and shortlisting outcomes for each of the Stage A, Stage B, Stage C and Stage D. The term 'team' in the table refers to teams composed of entrants in accordance with the criteria in **chapter D.3** and which have successfully been admitted into the Think Tank in accordance with the same chapter.

The Jury Panel reserves the right, at its sole and absolute discretion, to disqualify any Entrant or Entry at any time, including after any award or announcement has been made, by giving immediate notice in writing to the affected Entrant. An Entrant and/or Entry may be disqualified from the Think Tank for any of, but not limited to, the following reasons:

“JTC” means Jurong Town Corporation, a **body corporate** established under the Jurong Town Corporation Act 1968.

“Member” means, in relation to an Entrant, each individual comprising that Entrant.

“Organiser” means each of JTC and SIA, and **“Organisers”** shall be construed accordingly.

“Resolution Notice” is defined in **Clause 8.12.1**.

“SIA” means the Singapore Institute of Architects (UEN S63SS0027H), a company incorporated under the laws of Singapore.

“SIAC” is defined in **Clause 8.14.2**.

“Stage” means a stage or phase of the Think Tank as further described in **Chapter D.2.II**, and **“Stage A”**, **“Stage B”**, **“Stage C”** and **“Stage D”** shall be construed accordingly. Unless the context otherwise requires, (a) where a Stage is divided into Sub-stages, references to that Stage shall include all Sub-stages of that Stage, and (b) references to a “Stage” shall include a “Sub-stage”.

“Stage A IP” means Think Tank IP created, developed and submitted together with or as part of an Entry by or on behalf of an Entrant in Stage A.

“Subsequent Stage” is defined in **Clause 3.3.2**.

“Subsequent Stage IP” means Think Tank IP created, developed and submitted together with or as part of an Entry by or on behalf of an Entrant in Stage B, Stage C and/or Stage D (as the case may be).

“Sub-stage” means a sub-stage or phase within Stage B and Stage C, as further described in **Chapter D.2.II**, and **“Stage B1”**, **“Stage B2”**, **“Stage C1”**, **“Stage C2”** and **“Stage C3”** shall be construed accordingly.

“Terms” means the terms and conditions governing the Think Tank as set out in **Chapter D.1 to D.17** of this Think Tank Brief.

“Think Tank” means this think tank for “Pioneering a New Industrial-Residential Typology for Work, Living and More”, as further described in this Think Tank Brief, including Stage A, Stage B, Stage C and Stage D.

“Think Tank Brief” means this document entitled “Think Tank Pioneering a New Industrial-Residential Typology for Work, Living and More”.

“Think Tank IP” means all Intellectual Property that is created, developed and submitted together with or as part of an Entry by or on behalf of an Entrant in the course of or for the purposes of the Think Tank, including the Deliverables, but excluding Background IP.

“**Third Party Materials**” is defined in **Clause 4.1**.

“**Use**” is defined in **Clause 3.1.2(a)**.

“**Working Day**” means any day in Singapore other than a Saturday, Sunday or public holiday.

1.2 In these Terms, unless the context otherwise requires:

1.2.1 the singular includes the plural and vice versa;

1.2.2 a reference to an individual or person includes a corporation, partnership, joint venture, association, authority, trust, state, or government and vice versa;

1.2.3 a reference to any gender includes all genders;

1.2.4 a reference to the words “**include**”, “**includes**” or “**including**” shall not be construed as having any limiting effect;

1.2.5 headings are for convenience of reference only and do not affect the interpretation of these Terms;

1.2.6 a reference to a “**Clause**” is a reference to a clause of this **Chapter D.15**;

1.2.7 a reference to a “**Chapter**” is a reference to a chapter of this Think Tank Brief;

1.2.8 any capitalised term used in these Terms that is not defined in this **Chapter D.15** shall have the meaning ascribed to it in the other Chapters of this Think Tank Brief.

2 GENERAL TERMS AND CONDITIONS

2.1 Where an Entry is submitted by one Member on behalf of an Entrant, that Member submitting the Entry shall be deemed to have submitted the Entry for and on behalf of all the Members of that Entrant.

2.2 The Entrant and each of its Members shall be jointly and severally responsible for and bound by all licences granted, warranties, undertakings, and obligations under these Terms.

2.3 By submitting a registration to participate in the Think Tank or an Entry, the Entrant and each of its Members, jointly and severally, confirm that they have read and understood, and agree to be bound by, these Terms.

3 INTELLECTUAL PROPERTY

3.1 Background IP

3.1.1 Nothing in the Think Tank shall affect an Entrant's ownership rights to Background IP.

3.1.2 By submitting an Entry, each Entrant and each of its Members, jointly and severally, hereby grant:

5 WARRANTIES

- 5.1 Each Entrant and each of its Members, jointly and severally, hereby represent and warrant that:
- 5.1.1 the Entry (a) shall be the original work(s) of the Members (and not of any other undisclosed third party), and information contained in the Entry shall be complete, true, accurate, up-to-date and independently verified by the Entrant; and (b) will not infringe any copyright or any other intellectual property or proprietary rights, nor shall it violate any obligation of confidence.
 - 5.1.2 all copyright and intellectual property rights required for the Entrant to create, develop and submit the Entry as contemplated under these Terms, including all necessary written consents, permissions, permits or licences required under the Copyright Act 2021 and all other applicable laws, have been obtained in writing and fully paid for prior to the submission of the Entry;
 - 5.1.3 the Entry shall not contain anything of a libelous, illegal, tortious, immoral, obscene, offensive, religious, discriminatory, unlawful, scandalous or defamatory nature, or which shall or may expose the Organisers to any civil or criminal proceedings in any part of the world;
 - 5.1.4 they shall comply with all, and shall not cause the Organisers to be in breach of any applicable laws in relation to and in the creation, development and submission of the Entry, and the performance of its obligations under these Terms, including without limitation any employment laws and data protection laws;

 - 6.1.4 any neglect or default of such Entrant and/or any of its Members, in connection with such Entrant's and/or such Member's participation in the Think Tank or the performance of its obligations under these Terms.

7 AWARD SUMS

- 7.4 JTC having regard to the opinion of the Jury Panel where applicable, shall have sole and absolute discretion to determine whether an Entrant has satisfactorily complied with **Clause 7.1.3** in respect of any Stage or Sub-Stage, and any such determination shall be final and binding between the Organisers and the Entrant.

8.2 The rights and obligations in these Terms may not be assigned or otherwise transferred by the Entrant to a third party without the prior written consent of the Organisers.

8.3 Any waiver by any Party of any breach of any Term by the other Party shall not prevent the subsequent enforcement of that Term and shall not be deemed a waiver of any subsequent breach. No waiver by a Party shall be valid unless made in writing and signed by the authorised representative of such Party.

8.4 A person who is not a Party to these Terms (whether or not such person shall be named, referred to, or otherwise identified, or shall form part of a class of persons so named, referred to, or identified, in these Terms) shall not have any rights whatsoever under the Contracts (Rights of Third Parties) Act 2001 to enforce any of these Terms.

8.5 Nothing in these Terms constitutes any relationship of employer and employee, principal and agent, joint venture, or partnership between the Parties. No Party shall have any authority to bind the other Party in any manner without the prior written consent of the other Party.

8.6 If any provision of these Terms is held invalid, unenforceable or illegal for any reason, these Terms shall remain otherwise in full force apart from such provisions which shall be deemed deleted.

8.7 All notices or other communications (“**Notices**”) required or permitted to be given or made under these Terms shall be in writing and delivered by email or such other communication method as may be specified by the Organisers, to the email addresses or such other addresses specified in this Think Tank Brief or the Entrant’s application, registration and/or submission forms.

8.8 The Organisers may amend these Terms at any time by giving written notice to the Entrant. Any such amendment shall take effect after the date of such written amendment notice and shall apply prospectively only. An Entrant’s continued participation in the Think Tank following receipt of such written amendment notice shall be deemed to constitute the Entrant’s acceptance of such amendment. (a) if the Dispute is within the jurisdiction of the Small Claims Tribunals, refer the Dispute to the Small Claims Tribunals; or

(b) give the other Party written notice for mediation as contemplated in **Clause 8.13 (Mediation)**.

8.13 Mediation

8.13.1 In the event of any Dispute and subject to **Clauses 8.12** and **8.13.4**, the Parties must make reasonable efforts to resolve the same through mediation in accordance with the mediation procedure of the Singapore Mediation Centre and this **Clause 8.13**. The Parties shall be deemed to have made reasonable efforts in accordance with this **Clause 8.13** if they have gone through at least one (1) mediation session at the Singapore Mediation Centre.

8.13.2 A Party who receives a written notice for mediation from the other Party must consent and participate in the mediation process in accordance with this **Clause 8.13**.

8.13.3 The mediation session is to commence no later than ninety (90) days after the date of the written notice of mediation.

8.13.4 **Clause 8.13.1** shall not apply to a Dispute referred to the Small Claims Tribunals, provided that:

- (a) the Parties attend a consultation session before a Registrar (where the Parties will be given an opportunity to resolve the Dispute amicably) after a claim is filed with the Small Claims Tribunals; and
- (b) the proceedings relating to such Dispute are not:
 - (i) discontinued by the Registrar pursuant to section 17(3) of the Small Claims Tribunals Act 1984; or
 - (ii) transferred out of the Small Claims Tribunals before or pursuant to such consultation session.

8.14 Arbitration

8.14.1 Notwithstanding **Clause 8.12** and **Clause 8.13**, any Party may elect to refer a Dispute to arbitration in accordance with this **Clause 8.14** without first going through the procedures in **Clause 8.12** and **Clause 8.13**.

8.14.2 Any Dispute which is unresolved shall be referred to and finally resolved by arbitration administered by the Singapore International Arbitration Centre (“**SIAC**”) in accordance with the Arbitration Rules of the SIAC (“**SIAC Rules**”) for the time being in force, which rules are deemed to be incorporated by reference in this clause. The seat and venue of the arbitration shall be Singapore. The tribunal shall consist of a sole arbitrator. Any Party may propose in writing a sole arbitrator to the other Parties. The Parties shall have thirty (30) days from the date of the first written proposal to agree upon the nomination of the sole arbitrator. In the event the Parties are unable to agree on the nomination of a sole arbitrator within such timeline, or if none of the Parties proposed any sole arbitrator within (30) days of the commencement of the arbitration, the sole arbitrator shall be appointed by the President of the SIAC in accordance with the SIAC Rules. The decision of the tribunal shall be final and binding on both Parties. The language of the arbitration shall be English. The law governing this arbitration agreement shall be the laws of Singapore. The Parties hereto undertake to keep the arbitration proceedings and all information, pleadings, documents, evidence and all matters relating thereto confidential.

8.14.3 The provisions of **Clause 8.14.1** and **Clause 8.14.2** shall not prevent any Party from applying to court for any injunctive or equitable relief, and the Parties hereby submit to the exclusive jurisdiction of the Singapore courts for this purpose.

8.14.4 For the avoidance of doubt, neither the escalation of a Dispute under **Clause 8.12** nor the reference of a Dispute to mediation under **Clause 8.13** shall:

- (a) be a condition precedent to the reference of such Dispute to arbitration under this **Clause 8.14**; or
