Synopsis:

Session 1: DfMA in construction : The way forward

Design for Manufacturing and Assembly (DfMA) approach transforms the way we design and construct buildings and infrastructures. The DfMA continuum includes impactful prefabrication technologies such as Prefabricated and Prefinished Volumetric Construction (PPVC), Mass Engineered Timber (MET), Advanced Precast Concrete Systems (APCS), Structural Steel, as well as prefabricated Mechanical, Electrical and Plumbing (MEP) systems.

An upstream consideration in the DfMA practise would reduce construction time and achieve better end result. The speaker will share government initiatives for adopting DfMA systems in Singapore projects. He will also share the experiences from the early DfMA projects.
